The Curriculum on Governance for the Sustainable Development Goals aims to promote critical understanding of sustainable development issues, enhance governance capacity and strengthen public servants' awareness of their role in contributing to the achievement of the SDGs.

The Curriculum is composed of the following:

- A set of Training of Trainers Capacity Development Toolkits for 5-day face to face capacity development workshops. The trainings can be longer or shorter in duration, depending on countries' needs;
- Online Courses on key governance issues to implement the SDGs;
- Facilitated Online Training and Capacity Development Workshops;
- Customized Online and Offline Capacity Development Workshops upon request of Member States;
- Offering a Certificate of Attendance upon successful completion;
- Global Community of Practice on key governance issues;
- Hosted on UNPAN for networking and online exchange of knowledge.

Background & Methodology

- > In view of the preparation for the 2023 SDG Summit, UN DESA/DPIDG designed a Survey to capture information from Schools of Public Administration on mainstreaming the SDGs into their courses.
- > This Survey aimed to provide a snapshot of the current situation of the existing SDG courses and activities aimed at raising awareness of SDGs among civil servants.
- > It was administrated to around eighty institutions among schools of public administration, institutes of training, and civil service commissions from November to December 2022. 20 answers from 19 institutions were received.
- > The questionnaire included ten questions on the work that schools of public administration, are carrying out in terms of training courses for the SDGs.



1. Mainstreaming the SDGs into the Curricula of Schools of Public Administration: Key Trends

Most respondents indicated that they had mainstreamed the SDGs into their training courses or programmes.

AFRICA

SDGs had been mainstreamed into District Development Strategies. SDGs were also mainstreamed into gender, peace, conflict, and public administration and governance courses.

CENTRAL AMERICA

SDGs were mainstreamed into courses related to environmental management, and local development.

ASIA AND THE PACIFIC

Mainstreaming Goals 3 (Good Health and Well Being), 5 (Gender Equality), 9 (Industry Innovation and Infrastructure), and 10 (Reduced Inequality). Also, climate change, environmental governance, leadership, futures thinking, and SDGs localization were mainstreamed into courses.

EUROPE

SDGs have been integrated into several courses



1. Mainstreaming the SDGs into the Curricula of Schools of Public Administration: Key Trends

Tailored to Level of Seniority

Training on the SDGS is tailored to different needs and levels of seniority, including entry-level, mid-level to senior-level management civil servants, regular in-service training and postgraduate courses

2. Training material or tools or methods to advance the implementation of the SDGs

- Collaborative learning methods, online training, interactive discussions, engaging seminars on the SDGs, workshops, masterclasses, focus groups, and study
- Policy notes/strategic intelligence mapping after the training, statistics reports, data, current aggregated information on SDGs and futures thinking tools such as casual layered analysis, scenario building.
- Digital training material, such as a toolkit, in every pillar of SDGs; leaflets to popularize SDGs in various languages; UN material, including the 2030 Agenda and African Agenda 2063 and ECOSOC Principles of Effective Governance; Importance of media platforms for broader reach among the audience.



3. Raising Awareness of the SDGs and New training demands needed to progress on **SDGs** implementation

Raising Awareness of the SDGs

Eighteen institutions mentioned that they raise awareness of the SDGs (through cascading of activities including webinars, workshops, certificate courses, research activities, etc.)

New training demands needed to progress on SDGs implementation

- Digital governance, digital literacy; public-private-people partnerships; implementation of the SDGs, localizing SDGs; overcoming poverty and Training of Trainers
- Lectures and exercises on the themes of "Climate Change" and "changing mindsets of civil servants," and Leadership; customized induction handbooks and best practices workshops for implementing SDGs
- Having short and very practical and engaging courses on specific issues (budgets aligned to the SDGs, sustainable public procurement, and policy coherence for sustainable development)



4. Challenges faced in terms of teaching the SDGs or mainstreaming them into courses

Most of the surveyed institutions mentioned different challenges faced in terms of teaching the SDGs or mainstreaming them into their courses and wrote about the measures taken to tackle them.

- 1. Delivering quality online learning training for a more significant impact
- 2. Need for more human capacity and financial resources and the need to partner with other institutions, which proves to be time-consuming and complex at times
- 3. Importance of having experienced trainers on the subject matter of the SDGs
- 4. Leadership commitment



5. Collaboration with other training/academic institutions to advance the teaching and training of the SDGs

One of the key trends that emerged from the survey is that public administration institutions need collaboration with other training/academic institutions to advance the teaching and training of the SDGs, including Ministries and Universities.



































Most of the surveyed schools indicated need for training programs, ToT, and material. Technical advice and capacity development support. Adaptation of the Curriculum on Governance for the SDGs was also identified.

Topics: Surveyed institutions are interested in governance, innovation, leadership, transparency, and integrity, social inclusion and changing mindsets in public institutions.







