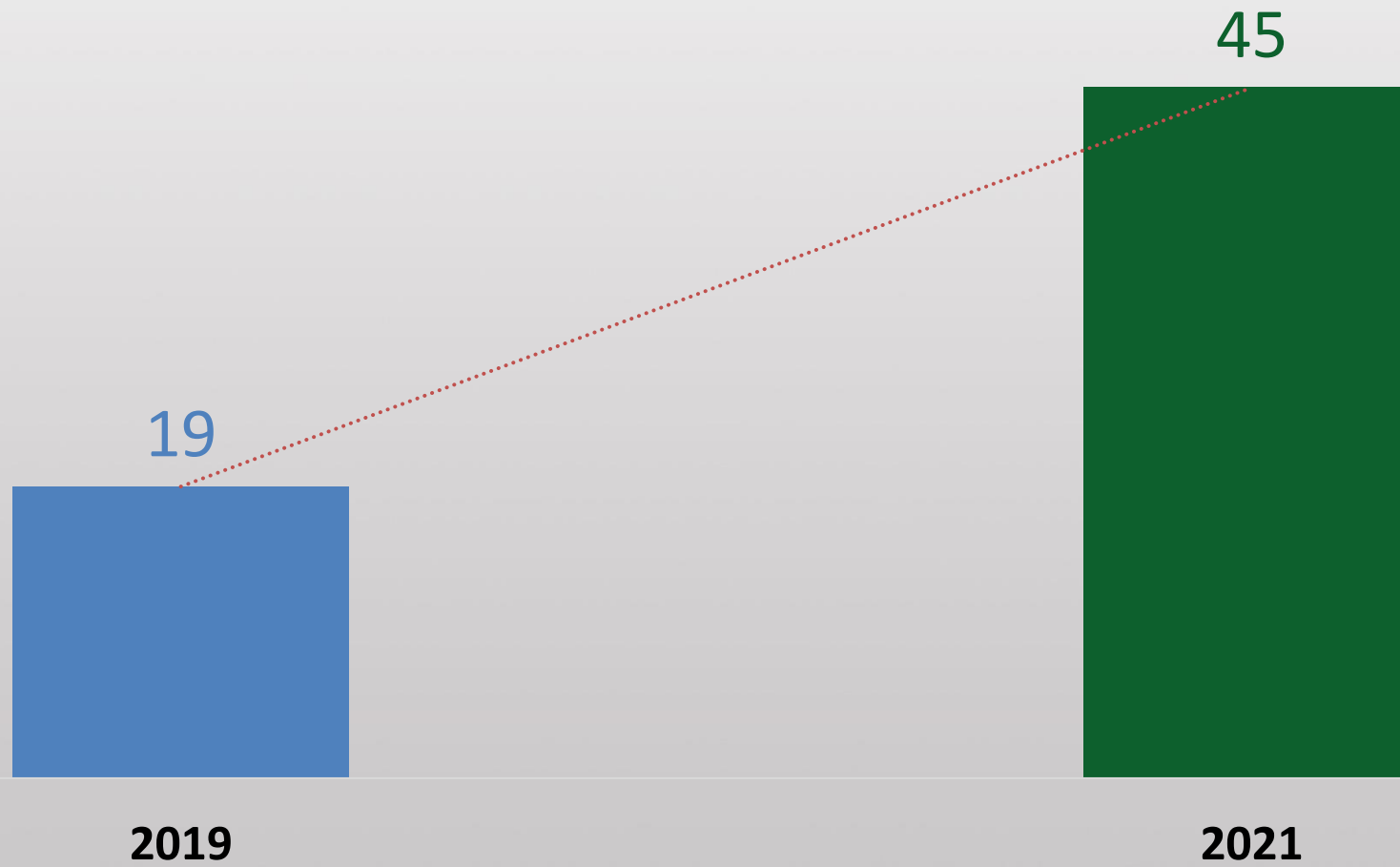

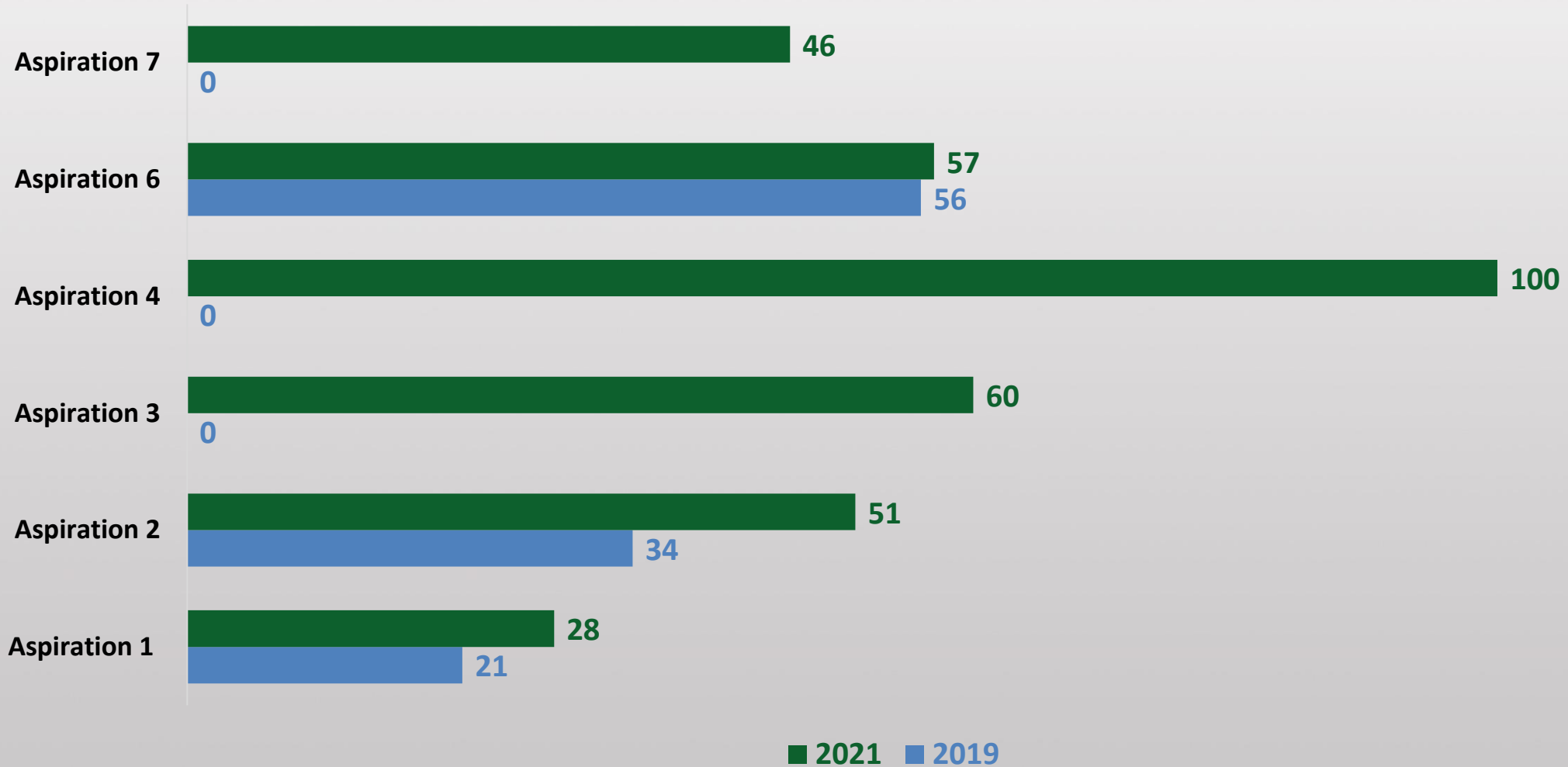

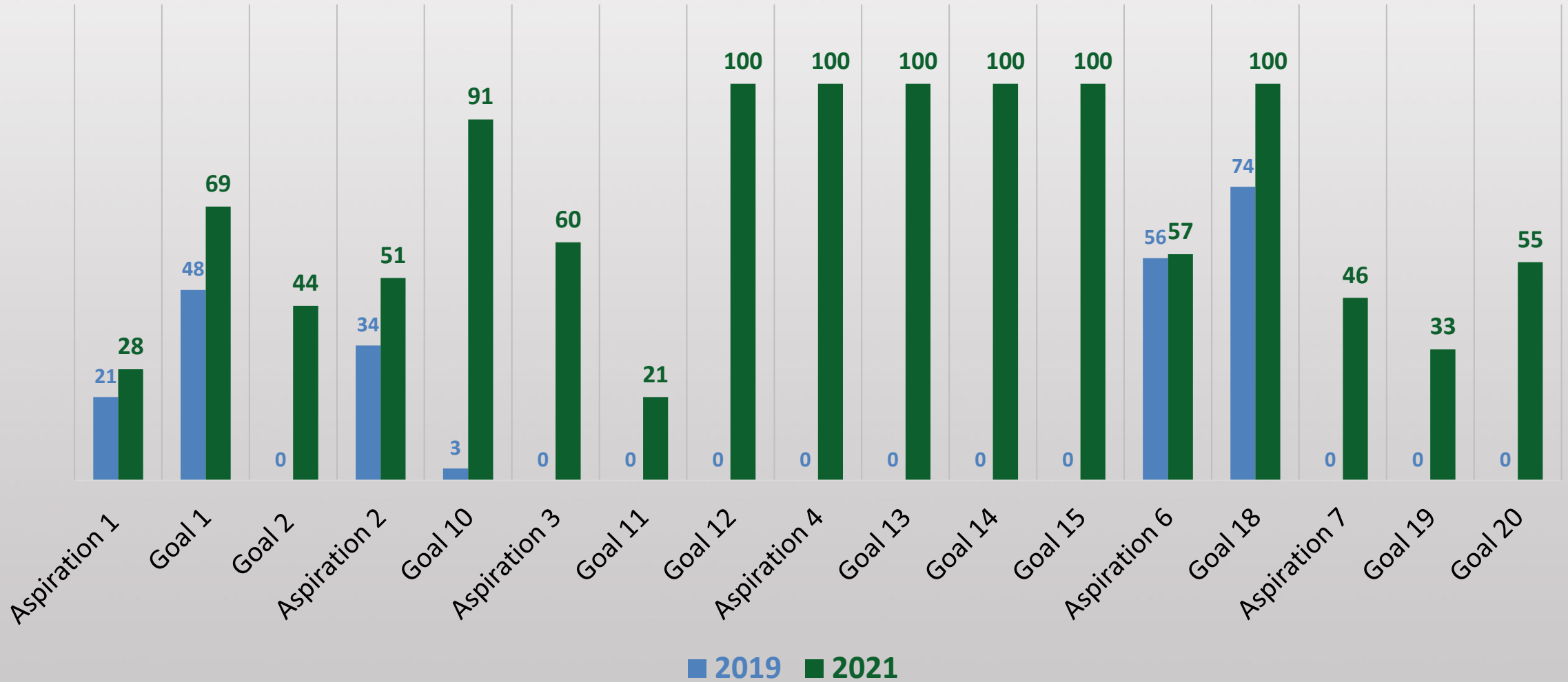
Overall Score

According to the Global indicator framework for the Sustainable Development Goals – or proxies



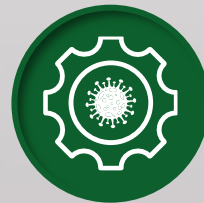
Documenting Partnerships:

The M&E frameworks adopted to report on Agenda 2063 and VNR

Agenda 2063

- ✓ Designate Egypt team to map-out the process of preparing Agenda 2063 reports (CAPMAS-MPED).
- ✓ Coordinate the process of harvesting required data and constructing proxies if the indicator is not available.
- ✓ Enter required data and undertake initial analysis.
- ✓ Validation of data among the range of stakeholders (either national or from AUC/NEPAD team).
- ✓ Finalise data entry into the matrix.
- ✓ Prepare first draft (narrative) of the country report.
- ✓ Validate the report among key stakeholders.
- ✓ Finalise the country report and submit.

VNR 2021



The participatory approach (PA) was maintained and emphasized while preparing 2021 VNR.



PA aimed to encapsulate the active contribution of the NGOs, private sector, UN-agencies alongside with strategic governmental partners for instance different sustainable development units in different ministries.



CAPMAS enriched the VNR with essential data and figures that make up the backbone of chapter five of this VNR measuring the progress in goals and targets.
