22nd session of the Committee of Experts on Public Administration (CEPA)

In its 22nd session held from 27 to 31 March at UN Headquarters in New York, the UN Committee of Experts on Public Administration (CEPA) discussed key aspects of the theme Urgently transforming institutions for a greener, more inclusive and more resilient world at a time of multiple crises. The session focused on institutional mechanisms for providing support to address climate change; ways to respond to the effects of climate change in institution-building efforts in fragile countries and countries emerging from conflict; the application of the UN principles of effective governance for sustainable development for the achievement of the SDGs; ways to reinvent public sector workforce training and institutional learning towards changing mindsets in the public sector; public financial management in times of emergency and implications for budget credibility; and ways to stimulate public sector innovation through digital technology and measure the impact of digital government. The Committee also engaged in a dialogue with voluntary national review countries and voluntary local review cities to promote peer exchange on experiences and promising practices in implementing SDG 16 - Peace, justice and strong institutions and SDG 17 - Partnerships for the Goals. CEPA also plans to hold a dedicated consultation with observers. The Committee adopted an input to the High-Level Political Forum in July and a draft resolution for ECOSOC. 
Transforming Public Service Delivery through Human-Centered Design and Collaborative Governance

Online Conference on International Benchmarking Study: Public Sector Performance 2022 Edition – Eipa was held from 2-3 February. In search for practices which lead to excellent performance, the European Institute of Public Administration (EIPA) and the Ministry of the Interior and Kingdom Relations of the Netherlands have performed a study to evaluate the effectiveness, efficiency, cost-effectiveness, satisfaction and trust of citizens, enterprises and other relevant stakeholders regarding available products, services, provisions and outcomes in ten policy areas. 35 countries were evaluated, with a longitudinal perspective. During the conference, the results of the in-depth analysis of the first four policy areas (public administration, education,



housing and social safety) were shared and discussed.

Knowledge sharing in organisations can take place in multiple directions such as horizontally (among colleagues at the same level of the hierarchy) and vertically (among the different levels of hierarchy such as knowledge flow from top to bottom or bottom to top).

Often, the immediate leaders can influence knowledge sharing within all these directions by developing a conducive or obstructive environment. How leaders interact and transmit trust within the organisation will help to deploy an efficient knowledge management culture, of openness and transparency.

The round-table covered:

- Knowledge sharing in organisations;
- Various factors that can affect knowledge sharing, including interpersonal trust, organisational culture, organisational support, and rewards;
- The role of leaders in promoting knowledge sharing;
- How employees who follow their leaders can contribute to and enhance the knowledge-sharing culture within an organisation.

The EHDS is subject to the General Data Protection Regulation (GDPR) and other relevant laws, and patients have the right to access, correct, and delete their own health data. Therefore, the success of the EHDS depends on cooperation among stakeholders, including healthcare providers, researchers, patients, and policymakers. Advancing Artificial Intelligence Impact in Dubai

Innovative Artificial Intelligence (AI) and dataheavy applications have become a driving force in digital advancing the globally. economy The scope and scale of their use cases have reached sophisticated levels of maturity around the world, with feasibility and impact increasing rapidly. These transformations have triggered diverse new business models, as well as influential societal innovations and impactful use cases in government operations and policymaking cycles. A widely present example today is the continuously evolving applications of AI-driven chatbots over the past decade. Today, their applications have reached sophisticated levels of maturity driven by advancements in Generative AI and Large Language Models. The rapidly expanding digital readiness of societies, coupled with the digitization of private and public sector organizations, suggest that the impact of these transformations will only expand on disrupting business models, labor markets and service delivery approaches across the economy. In such cases of transitions through rapid digital transformations, the policy, regulatory and ethical implications for societies and economies tend to go through turbulent phases. What are the gaps, challenges and future policy directions to grow the digital economy and drive AI impact towards public value creation, while governing the transition responsibly? The Mohammed bin Rashid School of Government (MBRSG), in partnership with Dubai Digital Authority and with the support of Microsoft conducted a comprehensive study to identify opportunities and challenges to AI adoption in Dubai and the future of the its digital economy. The ultimate aim of the study is to distil policy directions and recommendations both informed by international best practice but rooted in localized policy, socioeconomic, legal and cultural contexts.

The Global Economic Diversification Index 2023

Economic diversification has been a guiding policy commodity theme for producing nations minimize volatility. support economic growth and development create jobs alongside greater private

activity and more sustainable public finances. While research about economic diversification centers around

its determinants and the impact of policies on economic development, there had been no agreed, available measure or index of economic diversification till the first edition of the Global Economic Diversification Index (EDI) was published in 2022. The EDI measures and ranks countries on the extent of their economic diversification from a multi-dimensional angle, exploring diversification of economic activity, international trade as well as of government revenues (away from a dependence on natural resource or commodity revenue).

The EDI is based solely on quantitative indicators, with no survey or perception indicators, providing a quantitative benchmark and ranking of the economic diversification of countries, using 25 publicly available indicators, data and information. This edition of the EDI extends the coverage to a total of 105 countries, for the period 2000 to the Covid19 affected 2020 and 2021, allowing an international, cross-country, regional comparison and ranking of commodity dependent countries.

The United States, China and Germany hold on to their top 3 positions in this edition of the EDI. Nations that rank 4th to 10th have only a 6-point difference between them, highlighting the strength of diversification among the highly ranked countries. Three oil producing nations remain in the bottom 10 nations across the period, but the MENA region has recorded an improvement towards the latter part of last decade (supported by the acceleration of many oil producer's diversification plans). Overall regional rankings held steady even during the pandemic years though the scores were much lower with North America topping the list. The analysis highlights that while commodity dependent nations have made gains in both output and trade diversification sub-indices over time, revenue diversification has been holding back overall advances for many. Tax revenue as a % of GDP in Norway, highly ranked in the revenue subindex, stands at a high 30%+ and compares to single digit readings in countries like Bahrain, Iran or Kuwait, to name a few.

Following the onset of COVID-19, which put the brakes on non-oil sectors of focus (like tourism, infrastructure and logistics), there has been an accelerated shift in policies rolled out to enable economic transformation. This includes structural reforms (especially directed at the labour market and increased mobility), embracing the digital economy, efforts to broaden the tax base and a concerted push towards the privatisation of certain

state-owned assets and enterprises to de-risk fossil fuel assets among others. This will support the next phase of economic diversification in the region.


The Future of SMEs in the UAE

This report presents the results of pioneering national-level fieldwork by The Mohammed bin Rashid School Government (MBRSG), in partnership with Ministry of Economy and with support from Google. details how ramifications of COVID-19

in the UAE have impacted SMEs. Driven by data, the report aims to extract trends, develop lessons, and highlight policy directions that can contribute toward the ease of doing business across the SME ecosystem in the country. Through primary fieldwork, it extracts insights from the practical experiences of a sample of more than 280 SMEs and start-ups collected throughout an unprecedented and economically turbulent period. In doing so, the report's findings give voice to the diverse types of start-ups and SMEs that went through significant upheavals during that period. Building on the case of the UAE, the valuable findings presented here aim to contribute to developing evidence-based policy directions for the sector across the region.


2022 Arab SDGs Index and Dashboards Report

The Arab region continues to developmental face challenges on numerous fronts. The ongoing "Decade of Action for the Sustainable Development Goals" effectively started with a socioeconomic shock triggered global by pandemic. This further

disrupted developmental trajectories in several countries in the Arab region, many of which were already going through violent conflicts or internal political turbulence. Today, accelerating efforts to achieve the Sustainable Development Goals (SDGs) is more pressing than ever.

At this crucial point in time, the objective of the Arab Region SDG Index and Dashboard is to provide a data-driven practical tool for governments, policymakers and other stakeholders to measure progress on the SDGs, and to highlight implementation challenges and data gaps. The 2022 Arab Region SDG Index and Dashboard comprises 110 indicators covering the 17 SDGs, each of which have an assigned score (0–100) and a traffic light color (green, yellow, orange, or red) to indicate performance. In addition, arrows visually indicate trends in progress towards achieving the goals for those indicators where data for multiple years are available.

Agile Government: Emerging Perspectives in Public Management

The governments of today are not able to transform and adapt to changes in the world around them, as demanded by their constituents. The nature of work, value of public goods, and the constant bombardment of crises are making the old bureaucratic

The concept of agile government is confused with terms like Agile Manifesto, agile governance, agility among others, and because of this, needs some unpacking.

This book is a deep dive into this topic. It offers insights from the theoretical development of the topic of agile government, some lessons from government practices around the world, and ongoing academic and policy research. The project is spearheaded by the Mohammed Bin Rashid School of Government, which is the first teaching and research institution in the Arab world focusing on public policy and governance.

Launch Event and Panel: The Future of SMEs in the UAE

The Mohammed Bin Rashid School of Government (MBRSG), in collaboration with the Ministry of Economy and with support from Google, launched a report titled "The Future of SMEs in the UAE - Drafting a Future Roadmap and Lessons for the Post-Pandemic Phase" at a policy workshop on 26 January 2023 at the UAE Government Accelerators.

The report is based on multi-year fieldwork study by the Policy Research Department at the MBRSG, identifying challenges that face small and medium-sized enterprises (SMEs) in the UAE, and proposing future policy directions to strengthen the sector. The report is based on a series of policy workshops and a country-wide survey involving around 500 start-ups and SMEs over the past two years, in addition to a series of interviews with stakeholders across the UAE. The findings of the fieldwork that was carried out during and after the height of the pandemic were also contrasted with earlier policy research by the School that explored the ecosystem just prior to the COVID-19 pandemic, providing a rare view on the emerging challenges and transformations in the sector.

Launch Event and Panel: The Global Economic **Diversification Index 2023**

The second edition of the Index, which is developed by the MBRSG in partnership with The World Government Summit, expands its coverage in 2023 to a total of 105 countries, up from 83 last year. It continues to cover all geographies, resource and non-resource-based economies over a period of 22 years. The Index quantifies countries' diversification journey globally, by specifically focusing on three aspects of diversification: Output diversification, trade diversification and government revenue diversification.

The EDI is the first comprehensive global assessment of diversification that allows international, cross-country, and regional comparison and ranking of countries. As a policy and decision making tool, it is designed to allow countries to visualize their global ranking on each measure of diversification (production, government revenue, trade), across regional and income groups and within their natural resource grouping. The data of the EDI is already informing policy pathways across governments and with international agencies around the world.

Towards an Arab Administrative Reform Process for the SDGs: Institutional Performance Measurement and Management

ESCWA, through its Governance and State-Building section / Governance and conflict prevention Division, organized on 9 March 2023, in partnership with UN DESA/DPIDGand OECD, a webinar on Public Administration Reforms for the Achievement of the SDGs in the Arab Region, particularly the role of Institutional Performance Measurement and Monitoring in increasing the overall effectiveness of public institutions.

The discussions highlighted the role of Institutional Measurement Monitoring as one area that helps increase the effectiveness of public administration. During this webinar, ESCWA presented the results of its preliminary survey launched in November 2022, which aimed to identify where Arab states stand in terms of evaluation of institutional performance, in terms of the 3 priority sectors, namely: Health, Education, and Social Affairs, which are crucial for upholding citizens' Trust and confidence in the state and public institutions. The results of this survey constitute a baseline to discuss and inform the Member States about institutional

performance measurement management, from the legal, institutional, and implementation aspects, and to identify challenges and opportunities, in order to prioritize the capacity-building needs to be provided by ESCWA, as identified jointly with the participating Member States, in this area.

The discussions highlighted the weaknesses of monitoring and evaluation in public sector institutions, comparatively, in several countries in the Arab region, and mostly those in fragile and conflict settings. It also emphasized the need for regional workshops, training programs, and capacity building for civil servants to implement monitoring and evaluation techniques, enhance their skills and develop implementation guidelines, and training manuals.

3 key messages:

- 1- Public institutions in several Arab countries still face challenges in implementing performance measurement, monitoring, and evaluation processes. Results-oriented public administration performance is lacking in most cases.
- 2- Substantial efforts are still required to enhance the skills and culture of performance measurement and performance reporting in public institutions in the Arab region.
- 3- Several Arab countries require capacity-building and technical assistance to enhance the effectiveness and performance of their public institutions, including in the field of monitoring and evaluation, policy coherence, and the overall changing of mindsets.
