The UN Committee of Experts on Public Administration (CEPA) met for its 14th Session in New York from 20 to 24 April 2015. Experts from over 20 countries discussed the crucial role of public administration and governance for the achievement of proposed sustainable development goals ahead of the United Nations Summit to adopt the post-2015 development agenda this September.

The 14th CEPA Session, which focused on the theme of *Building Trust in Government in Pursuit of the* Sustainable Development Goals: What Will it Take was opened by Under-Secretary-General for Economic and Social Affairs Mr. Wu Hongbo. "You are meeting at a historic moment", Mr. Wu noted referring to the ongoing intergovernmental deliberations to define the post-2015 development agenda before highlighting the crucial role of public administration in achieving the goals of the new development agenda.

"From ending hunger and poverty, to ensuring quality education, healthy lives, gender equality, and access to water, energy, sanitation, employment, infrastructure, and to reducing inequality, emissions, unsustainable consumption, and to protecting oceans and our ecosystems - none of these goals and their related targets could be achieved without efficient, effective, inclusive, accountable and robust public institution", Mr. Wu said.

"The vital role of institutions is built into the sustainable development goals themselves," said Ms. Margaret Saner, the Chair of CEPA, making particular mention of Goal 16, which will call for effective, accountable and inclusive institutions at all levels, in tandem with promoting peaceful and inclusive societies and access to justice for all. It was noted throughout the week long discussions that the proposed sustainable development goals (SDGs) present both tremendous opportunities as well as complex challenges to public institutions.

Mr. Wu underlined the importance of changing mind-sets noting that many government institutions work in silos. "With the adoption of the SDGs, which emphasise the three interlinked dimensions of sustainable economic growth, social progress and environmental protection, this traditional mindset will no longer work. We must therefore get rid of silos, think out of the box, and try to bring the holistic approach into the mainstream of public institutions", he said.

Highlighted in this year's session was the importance of building citizens' trust in government. For example, 2012 data from Organisation for Economic Co-operation and Development (OECD) showed that only 40 per cent of citizens in OECD countries trust their government. "There is need for governments to dialogue with their citizens more effectively to better understand citizen expectations: to keep as close as possible to citizens in designing, developing and implementing policies and programs that affect them. This will be particularly important in attempts to achieve progress on the SDGs", **Ms. Meredith Edwards**, CEPA Member noted.

Assistant-Secretary-General for Policy Coordination and Inter-Agency Affairs **Mr. Thomas Gass** made a presentation on the status of the SDG negotiations and the expected historic impact of the SDG and the post-2015 development agenda; Assistant-Secretary-General Economic Development **Mr. Lenni Montiel** held an interactive discussion with CEPA on the role of public administration and governance in implementing SDGs and the post-2015 development Agenda; Deputy Executive Director of UN-Women **Ms. Lakshmi Puri** spoke on gender equality and empowerment in advancing sustainable development. Colleagues from the Division for Sustainable Development, the Statistics Division and the Office of Economic and Social Council (ECOSOC) Support and Coordination also made presentations to CEPA Members.

Next year's session of CEPA will be held from 18 to 22 April 2016. The Committee has proposed "Moving from commitments to results: transforming public institutions to facilitate inclusive policy formulation and integration in implementation and monitoring of the SDGs" as the focus of its work.

UNPAN Partners' Meeting



The United Nations Public Administration Network (UNPAN) Partners' Meeting was held on 21 April 2015 as a side-event of the 14th CEPA Session. The Meeting, opened by Assistant-Secretary-General for Economic Development **Mr. Lenni Montiel**, was attended by 15 representatives from 12 UNPAN partner organizations: AAPAM, ASPA, CAFRAD, CPSI, ESCWA, IIAS, INAP, IMPA-HR, IPAC, MBRSG, NISPAcee and RCOCI. Asian Association for Public Administration, Harvard Kennedy School of Government and the Office of the Prime Minister of Namibia participated as Observers. The 1st Session of the Meeting focused on reviewing the work of UNPAN in 2014 and the 2nd Session was dedicated to discussion on UNPAN's contribution to the post-2015 development agenda and the sustainable development goals. UNPAN Partners indicated strong support and interest in linking the work of the Network to the new development agenda, especially the proposed goal 16. Suggested UNPAN activities on SDGs included online training courses, joint meetings and publications with UNDESA's Division for Public Administration and Development Management (DPADM), sharing of sustainable development best practices and innovations as well as awareness raising in the UNPAN Partners' respective countries and regions.

2015 United Nations Public Service Awards Winners

UN/INTOSAI Symposium: Embedding Accountability for Sustainable Development



The 23rd United Nations/International Organization of Supreme Audit Institutions (UN/INTOSAI) Symposium was held in Vienna, Austria, from 2 to 4 March 2015. The participants of the Symposium discussed the topic UN Post-2015 Development Agenda: the Role of Supreme Audit Institutions and Means of Implementation for Sustainable Development.

The President of Austria inaugurated the meeting addressing representatives and heads of Supreme Audit institutions (SAIs) from more than 90 countries. In his address **President Heinz Fischer** highlighted the important role of Supreme Audit Institutions in monitoring performance in the implementation of the post-2015 development agenda at the national level and in that context the need for strengthening the independence of SAIs.

Under-Secretary-General for Economic and Social Affairs **Mr. Wu Hongbo** noted in his opening remarks that "Member States and the public at large have both underscored the critical role of effective and accountable institutions in implementing the post-2015 development agenda. SAIs are at the core of effective, accountable and inclusive institutions". Mr. Wu further noted that UNDESA "working closely with key partners, including INTOSAI, is committed to supporting national efforts, particularly in developing countries, to foster efficient, transparent and accountable public governance and administration".

Secretary General of INTOSAI, **Mr. Josef Moser** reminded the participating SAIs that "it is our task to do everything possible to safeguard sustainable development". He stressed the prerequisites for SAIs to contribute to the implementation of the post-2015 development agenda to meet growing expectations. The Under-Secretary-General of Internal Oversight Services **Ms. Carman L. Lapointe** made a presentation on lessons learned from the Millennium Development Goals and underlined the need to establish indicators and a baseline for monitoring the progress in implementation of SDGs by sharing methodologies for audit. Representing the Chair of INTOSAI, **Mr. Zhang Tong** mentioned the concepts of real time audit of livelihoods being tried out in China and stressed the need for collective wisdom and joint efforts.

The Symposium covered three themes -- expectations of the stakeholders ranging from citizens through parliaments and governments to donors, prerequisites for SAIs to play their role and the possibilities for INTOSAI, together with 193 member SAIs, to meet the expectations from them.

As many as 30 presentations were made on the three themes. Among them, **Ms. Jennifer Thomson** from the World Bank stressed the need for expanding the scope of audits by SAIs and **Ms. Margaret Saner**, Chair of UN Committee of Experts on Public Administration, underlined the importance of professional standards, code of conduct, independence, deep knowledge and skills combined with the ability to work collaboratively and across systems and themes. Representing citizens, **Mr. Amitabh Mukhopadhyay** mentioned their vulnerabilities and stressed greater intensity of efforts by

SAIs in fighting corruption, establishing shared accountability for public-private partnerships and undertaking performance audits for addressing issues in gender-responsive budgeting as well as of the regulatory process in protecting the environment.

In his concluding remarks for the Symposium Mr. Wu Hongbo highlighted that "SAIs play a key role in promoting an efficient, accountable, effective and transparent public administration, which is central to the implementation of sustainable development goals and the post-2015 development agenda. In that context, Member States are encouraged to give due consideration to the independence and capacity-building of SAIs, in a manner consistent with their national institutional structures, as well as to the improvement of public accounting systems". Mr. Josef Moser urged the SAIs to actively play their part in preparing for and furthering the SDGs.
