The handbook explores different approaches to auditing budget credibility. Drawing on SAIs' experience in different regions, the result is a practical overview of existing and potential audit work that can contribute to improving budget credibility. The AAPAM leadership development and training toolkit focusing on the CEPA principle of competence advocates for ToT as a strategy to enhance competence in public administration as well as raising a community of experts capable of delivering training programmes thus creating a continuous knowledge transfer value chain. If implemented, this strategy can simultaneously address the financial resource challenges as well as competency needs geared towards organizational productivity and performance in Africa and Palestine. Organisational Review and Reclassification – Public Service of the Commonwealth of Dominica

The Caribbean Centre for Development Administration (CARICAD) recently concluded an Organisational Review and Reclassification (ORR) exercise in the Public Service of the Commonwealth of Dominica (PSCoD). This exercise was in response to Dominica's National Resilience Development Strategy (NRDS) and its Public Sector Transformation Strategy (2021 – 2025). CARICAD adopted a holistic approach to assess the status of the public service, against the vision for resilience in terms of capacity, structure, and compensation. This encompassed a series of reviews and interventions designed to optimize organisational performance. The ORR provided essential insights regarding the human resource (HR) 'infrastructure' and the enabling environment required to facilitate good climate governance and resilient development for the Commonwealth of Dominica. Bearing in mind the transformative context, the ORR was not just about addressing present challenges in the public service: it was also about anticipating future hurdles. Bv streamlining the structure, understanding the true essence of each role and reclassifying them accordingly, the PSCoD, through the ORR, would have positioned itself for future sustainable growth and success. For other CARICAD member states looking to refine their outcomes-focused operational strategies, CARICAD's approach to the ORR serves as an insightful case study.

Risk-informed policymaking, Tunis, 4-6 July 2023

In light of the existing crises, conflicts, wars, climate shocks and development challenges in the Arab region, ESCWA has developed a tool and methodology adapted to the region's volatile environment to respond to its urgent needs and help strengthen cooperation between governments and policymakers. To that end, ESCWA and the Ministry of Planning in Libya are implementing a training programme that seeks to enhance the capabilities of the Ministry's team to capture, understand and interpret risks, analyse their effects and anticipate their future repercussions. The programme aims to aid participants in developing risk-informed policies that would maintain stability and achieve growth and prosperity.

During the workshop, participants conducted a deep dive into the factors contributing to the country's vulnerability and resilience. They were introduced to conceptual framework ESCWA's for assessing vulnerability and resilience, along with an examination of key risk trends spanning the past decade. Building upon the analysis, small groups were formed to address climate, conflict, and development pathways of risk. These groups dissected the root causes behind the country's vulnerabilities and proposed options to build resilience. Additionally, they devised various future scenarios aimed at enhancing prevention and mitigation efforts. A major focus of the workshop revolved around the challenges associated with effectively translating the outcome of risk assessments into public policies and programming.

The recommendations/Key Messages were as follows:

- Set up a dedicated team within the Ministry of Planning. This team would assume the responsibility of regular risk analysis and monitoring, leveraging ESCWA's quantitative Risk Monitor for Libya while also developing their own qualitative risk assessment modality.
- The team would collaborate with other ministries to form a national core group, encompassing a wide range of risk pathways.
- Strengthening risk-informed policy making in Libya, with ESCWA and its Libyan counterparts engaging in collaborative consultations to this end.

ESCWA launches an initiative to reform public administrations in the Arab region, Hybrid, 23 August 2023

The Arab region, with its diversity, faces complex and multifaceted challenges with regard to public administration, including governance weakness, institutional fragility, and an inability to address crises. Against this backdrop, ESCWA launched on 23 August 2023, during a meeting, a regional initiative to develop innovative pathways for public administration modernization and reform in the Arab region.

Governmental representatives, researchers and experts in the field of public administration from international



and regional organizations, discussed means to reform and modernize public administration systems and set priorities in this regard. This inaugural meeting paved the way for a long-term project aimed at reforming the public sector and charting its future, as the deadline for achieving the SDGs approaches.

Youness Abouyoub, Chief of the Governance and State-Building Section at ESCWA, emphasized that the quality of institutions was one of the main determinants of the differences in development outcomes between countries. He also stressed the need to reform and modernize public administrations to achieve the SDGs by 2030. "While this poses a significant challenge to the region's countries, it is possible to achieve a qualitative leap through sustainable reforms based on new and innovative ideas," he added.

Participants also discussed ways to enhance effective governance, the implications of digital governance on public administration reforms, and development challenges in the Arab region.

The discussions generated the following three key messages:

- Platform for Discussion: Establish a dynamic center for innovative ideas, influencing policy.
- Cross-Regional Exchange: Expand existing dialogue into an annual forum for sharing experiences and ideas across the Arab region.
- Launching a regional participatory process to focus on shared objectives by 2030 and to work collaboratively toward strengthening public institutions, and promoting the implementation of SDG 16, as the enabler for the achievement of all other SDGs.

Improving the quality of public services in the occupied Palestinian territory, Beirut, 28-29 August 2023

ESCWA held a workshop on 28 and 29 August 2023 at the United Nations House in Beirut, where Palestinian experts and practitioners discussed means and options to enhance the capacity of Palestinian institutions to provide improved public services, despite the restrictions imposed by Israel.

Seventeen experts from public, private, civic and academic institutions participated in the workshop and discussed ESCWA's assessment of impact of the occupation on the ability to deliver public services Participants also reflected on the structural challenges, affecting the quality and capacity of services provided by Palestinian institutions, whether in infrastructure, basic services, or the civil and administrative sectors.

Participants then explored possible policies and measures that would improve the quality of public services that take into account structural and occupation-related challenges. Participants finally deliberated about role that ESCWA and the international community could play to support Palestinian public service delivery.

The outcomes of the workshop constitute inputs to the national strategy to improve the quality and capacity of public services in the Occupied Palestinian territory. This strategy is currently being developed by the Government of Palestine, supported by ESCWA, through a programme funded by the Arab Fund for Economic and Social Development.

Key messages:

- The Israeli occupation continues to constitute the largest obstacle to the ability of Palestinian institutions to provide quality public services.
- There are public services that Palestinian institutions can improve in terms of quality and access.
- The international community and UN system should play a role to lift Israeli restrictions impeding the improvement of public services, particularly those that violate international law

Workshop on the Integration of the SDGs in National Planning Processes in the State of Palestine, Beirut, 4-5 September 2023

In collaboration with the Office of the Prime Minister of the State of Palestine, ESCWA held a workshop on 4-5 September 2023 at the UN House in Beirut on the Integration of the SDGs in National Planning Processes in the State of Palestine.

Members of the National Team for Sustainable Development Agenda 2030 in addition to officials from the relevant sections at ESCWA discussed means, mechanisms, and challenges and measures needed to integrate the SDGs into the national planning processes for the years 2024-2029. Discussions were based on the findings of the research and consultation process about priority goals and targets in the Palestinian context carried out by the ESCWA expert in coordination with the national team, as well as on the results of the evaluation conducted by ESCWA on the alignment of previous Palestinian development and strategic plans with the Agenda for Sustainable Development 2030.

The workshop included a dialogue with representatives from the Office of the United Nations Resident Coordinator in Zambia and the Ministry of Planning and Economic Development in Egypt about integrating the SDGs into national planning processes in both countries. Palestinian officials presented an overview about the planning and policy formulation experience of the State of Palestine with the Agenda for Sustainable Development 2030 and opportunities to benefiting from it in the development planning.

ESCWA briefed the participants about latest trends and changes in approaches related to the implementation of

the 2030 agenda and measuring progress therein. ESCWA also presented the approach developed by the Commission to integrate and mainstream the triple nexus (humanitarian - development - peacebuilding) in national programs and interventions and international aid frameworks, focusing on the case of the occupied Palestinian territory.

The outcome of this workshop will be presented to the Government of Palestine as part of the ESCWA's programme to support the Palestinian people which is funded by the Arab Fund for Economic and Social Development.

Key Messages:

- The conditions resulting from the matrix of Israeli policies and practices in the occupied Palestinian territory render the attainment of most of the SDGs almost impossible.
- Integrating the SDGs in Palestinian development plans must be contextualized and based on Palestinian national priorities and accounts for occupation-related limitations on planning and implementation.
- The Palestinian context requires shifting in the approach to development towards one that is more rights-based and in line with the humanitarian-development-peacebuilding triple nexus approach.

A seminar on competition law and policy, Beirut, 19 September 2023

Promoting competition policy among youth in the Arab region is crucial as it empowers them to actively shape the rapidly changing economic landscape, especially in the context of digital advancements. Understanding and supporting competition policy enables youth to make informed consumer choices, advocate for fair pricing, and demand high-quality goods and services.

As part of its mandate to advance competition policy in the Arab Region, ESCWA is actively working to engage youth in this field. One key strategy involves collaborating with universities across the Arab region to incorporate competition policy into academic curricula. This effort aims to raise awareness among students and involve them in understanding the importance of competition policy in promoting economic activities and development, particularly in the context of rapid digital transformation.

ESCWA in collaboration with the Department of Economics at the American University of Beirut (AUB), organized a seminar on competition law and policy on September 19, 2023, at AUB. During the seminar, experts, academics, and policymakers engaged in discussions with students, covering essential aspects of competition policy. These discussions explored the connections between competition policy and economic development, with an emphasis on its role in digital markets and the regulation of dominant positions.

The seminar conveyed several key messages including providing an interactive platform where students engaged with academic and policy experts in the field of competition. In addition, through active participation in discussions and debates about competition-related topics, students were encouraged to advocate for fairness and competitiveness within the economy. Furthermore, the seminar highlighted how competition law and policy are highly relevant in today's world, illustrating their importance to younger generations.

Countering economic dependence and dedevelopment in the Occupied Palestinian Territory, Feb 2023

The report analyses how Israeli policies and practices have eviscerated the economy in the occupied Palestinian territory, resulting in de-development and asymmetric

dependence on Israel. It examines the failure of the "development-as-usual" approach to development in the occupied Palestinian territory, which compounded the economic evisceration. The report also highlights the detrimental effect in this regard of prioritizing security, political and territorial considerations at the expense of international law and the rights the Palestinian people.

The report emphasizes the need for a shift in the development approach in the occupied Palestinian territory. It explores options to mitigate, and eventually counter the consequences of economic evisceration and other forms of de-development and social and economic deterioration.

The report proposes a three-pillar rights-based policy framework that seeks to decrease Palestinian economic dependence on Israel; mitigate the ongoing dedevelopment in the occupied Palestinian territory and its social and economic effects; and restore the prioritization of the application of international law and the fulfillment of Palestinian rights, especially the right to self-determination as prerequisite to development and peace. The report also proposes operationalizing the framework using a two-track policy agenda for each pillar: a track for short-term issues of immediate concern and a second for long-term strategic issues. Arab Risk Monitor: assessing vulnerability and resilience in the region, July 2023

The Arab region grapples with complex and protracted crises aggravated by a multitude of conflicts, climate shocks and development challenges. The damaging effects of these crises impacts people, societies

and institutions, and threatens to undo the progress made. This paper presents the key findings of the United Nations Economic and Social Commission for Western Asia Arab Risk Monitor, which assesses vulnerability and resilience to shocks in 22 Arab countries, exploring the issues shaping risks of conflict, crisis and instability. The analysis reveals that weak institutions, combined with the scarcity of natural resources, perpetuate a vicious cycle of instability and conflict. Over the past decade, the region's overall risk has increased, primarily driven by the devastating impact of recent conflict. Water scarcity, food insecurity and corruption emerge as key drivers of high vulnerability while inadequate social protection, water stress and a lack of accountability hamper the region's resilience. Amidst this challenging landscape, efforts to build resilience in the Arab region have shown promise, propelled by the increasing adoption of climate adaptation strategies, the expansion of social safety nets and a significant decline in infant mortality rates. By observing and interpreting structural trends, the Risk Monitor can serve to guide policymakers in the Arab region, development organizations and humanitarian actors who navigate increasingly complex polycrisis dynamics, integrate risk analysis into policymaking and planning, and ultimately advance the Sustainable Development Goals.



Development Challenges Index: impact of the COVID-19 pandemic, July 2023

ESCWA published the Development Challenges Index: impact of the COVID-19 pandemic paper. This paper provides an update on the Development Challenges Index (DCI) to better understand the impact of the COVID-19 pandemic, finding that development progress

has been either reversed or stagnated in all regions. In terms of the share of the three challenges within the overall DCI, no significant changes were depicted, and the governance component retains the largest share. As for the performance in each of the three challenges, the paper finds a deteriorating performance in all three with the governance component being the most impacted. Although, on average, richer countries perform better than poorer ones, the paper examines the DCI results by the different income per capita levels and finds striking differences between these and the DCI levels. Rising income per capita contrasts with accentuated development challenges, especially in the poorest countries. DCI scores by challenge level show that all challenge groups saw an increase or stagnation in their scores between 2019 and 2021, except for medium challenged countries. Trends and Impacts in Conflict Settings No. 7 Climate, peace and security in the Arab region

Trends and Impacts in Conflict Settings No. 7: Climate, peace and security in the Arab region, August 2023

The Arab region is facing the dual challenges of climate change and conflict. Ongoing conflicts and fragility exacerbate environmental degradation, limit resources for climate action and increase vulnerability to

climate impacts. Climate impacts, on the other hand, can affect known drivers of insecurity and conflict such as loss of livelihoods and income, food insecurity, competition for resources, and migration. These

compounding challenges could lead to a vicious cycle of climate vulnerability, insecurity and conflict unless addressed. Responding to such challenges is thus an imperative, but it is also a window of opportunity to promote peace and prosperity across the region. To this end, this report draws on the latest data with respect to fragility, climate change projections and security risks in the Arab region in order to provide a regional overview of climate security risks. This analysis is used to inform recommendations for policymakers, multilateral agencies and relevant stakeholders to mitigate climate security risks in the region. The report concludes that attention must be paid to inequities, the experiences of different population groups and the specificities of local contexts. The quality of governance and capacity of institutions play a key role in strengthening resilience and moderating the risk of tensions and insecurity. Importantly, integrated and cooperative approaches are vital to effectively address the nexus between climate change, peace and security. For more information, click here.

The boundaries of arbitration exclusion in the EAPO Regulation

The European Account Preservation Order consists of an interim measure at the EU level. It allows the temporary attachment of debtors' funds in cross-border civil and commercial claims. The EAPO Regulation states that it does not apply to 'arbitration'. The meaning of



'arbitration' is not a settled question among scholars and national courts. In this article, Dr Carlos Santaló Goris, Lecturer at the European Institute of Public Administration (EIPA), explores the underpinning debate surrounding the arbitration exclusion, focusing on the interpretation some national courts have made of it.

Op-Ed: Refugee Status Withdrawal: the CEAS and the Geneva Convention

Op-Ed: Refugee Status Withdrawal: the CEAS and the Geneva Convention (C-8/22, Commissaire général aux réfugiés and aux apatrides (Réfugié ayant commis un crime grave))

In its judgment of 6 July 2023, Commissaire général aux réfugiés and aux apatrides (Réfugié ayant commis un *crime grave*) (<u>C-8/22</u>), the Court of Justice rules on the interpretation of **Directive 2011/95** (the Qualification Directive). More specifically, Article 14(4)(b) of this directive provides that Member States may revoke the status granted to a refugee when he/she, having been convicted by a final judgment of a particularly serious crime, constitutes a danger to the community of the Member State in which he/she is present. The referring



court seeks interpretation of this provision to know whether conviction for serious crime allows to conclude that the existence of a danger to the community is verified. If that is not so, the referring court wants to know how to assess whether a recognised refugee constitutes a danger to the community. The Court provides useful answers to both questions. Its reasoning also raises further questions pertaining to the relationship between the EU's legal system –and more particularly, the Common European Asylum System (CEAS)–, the system established by the <u>Geneva</u> <u>Convention on the Status of Refugees</u>, and the legal systems of the Member States.

methodology-focused. The followed approach seems driven by the concern to avoid a Taricco-type constitutional conflict, especially in a context where the Romanian Constitution Court (RCC) has <u>already made</u> <u>use</u> of radical identity-related arguments. Yet this approach weakens the boldest suggestion of the Opinion: defining an autonomous EU standard of the principle of legality of offences and penalties (Article 49 of the Charter). The Opinion of Advocate General (AG) Manuel Campos Sánchez-Bordona in *Lin* (C-107/23 PPU) was eagerly awaited to shed light on the, at least apparently, unsettled case law of the Court of Justice regarding the articulation of the principles of dissuasive penalties in cases of serious fraud affecting the EU's financial interests and the retroactive application of the *lex mitior* (summary of the request available <u>here</u>). Following a hearing on 10 May 2023, the Opinion was delivered on 29 June 2023 and responded in a rather contrasted manner to those expectations.

While the Opinion follows an adamantly clear structure of reasoning, grounded on the aim of guaranteeing a very high level of protection of fundamental rights, it fails (most probably refuses) to address directly and unambiguously why and how a potential risk of impunity, liable to arise from the application of the *lex mitior* to the detriment of valid provisions of EU law, could and should be tolerated in some cases. Protecting Fundamental Rights in the Age of AI: How Parliament's latest version of the EU's AI Act safeguards fundamental rights

As artificial intelligence (AI) technologies continue to advance, risks to fundamental rights undoubtably surface. Amidst this evolving landscape, the EU's Artificial Intelligence Act seeks to act as a safeguard to citizens' fundamental rights. The <u>latest version</u> was adopted by the <u>European Parliament</u> in June 2023 and the next step is the final trilogue negotiations between the Commission, Council, and Parliament, with legislators hoping to have the Act adopted as soon as early 2024. In this case, it will apply at the earliest in 2025.

In terms of fundamental rights, after the publication of the <u>Commission</u>'s original proposal in 2021, several <u>concerns</u> were raised regarding rights protection by over 120 human rights and civil society groups. Arguably, Parliament's recent amendments significantly improve the safeguarding of fundamental rights in relation to AI, and these changes have been welcomed. We want to briefly explore some of the Act's major developments and any challenges that may remain regarding rights protection, particularly in the areas of non-discrimination, freedom of expression, and privacy.





EU Law Training Needs Assessment Survey

The European Institute of Public Administration (EIPA), in a consortium led by ICF, has been entrusted with a significant project, aimed at assessing the training needs of EU legal practitioners, by the Directorate-General for Justice and Consumers (DG JUST).

This project focuses on developing comprehensive training e-Capsules in three key areas of EU law: fundamental rights, civil matters, and criminal matters.

A critical part of this assessment involves gathering data from about 800 legal professionals across the 27 Member States through an online survey. A survey was designed to collect essential information about the training needs of legal practitioners.

Artificial Intelligence: Laws, Challenges and Opportunities; Online, 25-26 October 2023

Artificial intelligence has become the mainstream datadriven technologies during these last years due to its ability to drive transformation across multiple sectors. While the potential benefits of artificial intelligence technologies can be massive for growth and development, 'there is no such thing as a technological silver bullet'.

Over the last decades, the concept of data protection has been provoked by technological innovation, and with artificial intelligence technologies, it is no different. How can we responsibly develop artificial intelligence technologies and ensure strong legal and regulatory frameworks?

How can we ensure that collected personal data are used with positive benefits by artificial intelligence technologies?

How can we make sure we are not setting an undesirable precedent for the future?

What are the benefits and challenges AI systems can bring to our society?

These are some of the questions we are going to tackle during this course. With a particular focus on European policy-making and the European legal frameworks and proposals, we will pinpoint the challenges and opportunities posed by these new technologies and find clear methods to address such challenges as a precondition to develop an ecosystem of trust.

Fundamental Rights in the European Union: Main Principles and Contemporary Challenges Luxembourg (LU), 26-27 October 2023

The Treaty of Rome made no mention of human rights. Six decades later, fundamental rights are consecrated as one of the core values of the European Union and fundamental rights protection is a major concern in all of the EU's policy areas. Public administrations (whether EU or national) as well as private companies are expected to respect human rights and are closely watched in this respect by courts, EU institutions, shareholders, investors and civil society.

This course proposes to explain the legal and policy system that the EU has established over the years to protect and promote fundamental rights, to a point where fundamental rights have become relevant to all aspects of economic and social activities in the EU.

We will first discuss the place of fundamental rights in the EU system of legal norms and explain their role as a mechanism to control the legality of EU policies and instruments vis-à-vis individuals, whether exercised by the EU or indirectly by Member States. We will pay close attention to the Charter of fundamental Rights, highlighting the breadth of its scope and the innovative nature of many of the rights it enshrines. The efforts undertaken both by the EU decision-making institutions



and the Court of Justice of the EU (CJEU) to make the Charter effective will be examined.

We will also analyse the relationship of EU fundamental rights to other sets of legal rules (the Internal Market, the Area of Freedom, Security and Justice) and other legal systems: we will discuss the state of play regarding the EU's accession to the European Convention on Human Rights (ECHR), and we will also look at how the EU promotes the protection of human rights on a global scale.

Introduction to the Better Regulation Agenda Online, 3 November 2023

This course provides a thorough overview of the Better Regulation (BR) agenda and its implementation in the EU policy making. It includes an informative session explaining the key concepts of Better Regulation (BR) and how they are applied across the EU policy cycle. It presents the procedures and how the Better Regulation tools are used in practice in the European Commission (EC). It enhances the participants' knowledge on the BR agenda and stands as a comprehensive introduction to the specific BR courses on Regulatory Impact Assessments, Regulatory evaluations and Stakeholder consultation.

What you will learn in this course:

- the key concepts of Better Regulation and how they are applied across the policymaking cycle.
- how BR tools are used in practice in the European Commission (EC).
- what the principle of Subsidiarity is and how the ECs Better Regulation Guidelines and Toolbox set out assurances for this.
- how Member States (MSs) implement the Better Regulation Agenda and what the challenges and drawbacks of different approaches are.

Course methodology/highlights

The course is led by experts who have decades of both research and practical experience in using the Better Regulation instruments both in the EU context and beyond.

The course combines interactive presentations, practical examples and quick polls and group exercises to consolidate the concepts.

Strategic Foresight in Policy-Making: From Anticipating Surprise to Robust Strategy; Online, 6-7 November 2023

This course equips participants with the relevant knowledge about the most essential foresight tools, how these tools can be combined and what it takes to implement them.

Participants learn about explorative scenarios, horizon scanning, megatrends, Delphi analysis, and wild cards. More importantly, participants learn how to make foresight products useful for policy planning, by transforming foresights into strategic foresight.

Sustainable Finance in the EU: Regulatory Framework and Implementation; Online, 7-8 November 2023

What is sustainable finance?

Sustainable finance is a key driver of the transition to sustainable economic growth by taking into account considerations on Environmental, Social and Governance (ESG) issues for investment decisions. In the EU, initiatives to facilitate sustainable finance are an essential component of the **European Green Deal**. **EU regulatory framework**

At the heart of the regulatory framework on sustainable finance in the EU is the taxonomy regulation. The regulation establishes a classification of sustainable economic activities in line with the so-called Do No Significant Harm principle.

The course presents the regulatory framework of sustainable finance in the EU. It introduces the **EU taxonomy and related legislation** on reporting requirements for financial and non-financial institutions stemming from the taxonomy. It further reflects on the challenges of applying these requirements and provides good practices of implementation in the Member States.

- The key legislative acts of the EU sustainable finance regulatory framework, i.e. taxonomy regulation, green bond standard, Corporate Sustainability Reporting Directive (CSRD) and Sustainable Finance Disclosure Regulation (SFDR).
- The "do no significant harm principle" which is an integral part of the taxonomy and increasingly applied areas beyond sustainable finance, e.g. cohesion policy and the recovery.
- The implementation of the taxonomy and the reporting and disclosure requirements through technical criteria and standards at the EU level.
- The challenges of implementing the regulatory framework in the Member States and good practices of national authorities.

Introduction to the EU Succession Regulation Luxembourg (LU), 7 November 2023

The EU Succession Regulation (Regulation no 650/2012) sets out a unitary regime applicable to crossborder succession cases as it deals with the whole estate and does not make a differentiation between types of property: moveable and immovable property. At the same time, the Regulation provides uniform rules regarding jurisdiction, applicable law, recognition, and enforcement, also establishing the European Certificate of Succession.

This course aims to provide an exhaustive analysis of the Succession Regulation in light of the European Court of Justice's judgments about this instrument. Following the structure of the Succession Regulation, it dedicates one session for each part of this instrument, from its jurisdictional regime to the European Certificate of Succession.

What will you learn:

You will have the opportunity to learn the following:

- the scope of application of the Succession Regulation
- what rules determine the applicable law to a succession
- the recognition and enforcement regime of the Succession Regulation
- the issuance and characters of the European Certificate of Succession

You will learn about



• the most relevant contributions of the European Court of Justice case law to the interpretation of the Succession Regulation

Cohesion Policy Project Appraisal 2021-2027, CBA, and Economic Appraisal (Basic and Advanced) Online, 8-10 & 13-14 November 2023

This (2-stage) online course will focus on the new Project Appraisal requirements for EU co-financed investment projects and the new Economic Appraisal *Vademecum* of DG REGIO. It will clarify the link between the Cost-Benefit Analysis (CBA) Guide, CBA requirements and using the *Vademecum*.

For 2021-2027, major projects are no longer specifically defined. Nor will there be an EU approval mechanism for large investment projects co-financed under Cohesion Policy. However, Member states are still obliged to select the most cost-effective projects.

The new Economic Appraisal *Vademecum* provided by the EC for the period 2021-2027 is provided as a supplement to the European Commission (DG REGIO) CBA Guide, which will remain in use. It recommends proportionate efforts in project appraisal and highlights good sectoral practices. It offers a guide to simplified CBA and other appraisal techniques, such as costeffectiveness tests and multi-criteria analyses.

This 5-day course consists of 2 stages: Basic and Advanced.

Stage 1 Basic (8-9 November) takes place over two halfdays and it will cover the methods, concepts and calculations contained in the DG REGIO Cohesion Policy CBA Guide.

Stage 2 Advanced (10 & 13-14 November) spans three half-days. Leading experts from the European Commission, the European Investment Bank and the academic world will discuss:

- Best practice in using CBA for project appraisal
- Best practice lessons from Major Projects
- The new DG REGIO requirements
- Alternative project appraisal techniques; project quality standards, 2021-2027
- Using CBA for other instruments, such as the Connecting Europe Facility

EU Law for Non-Lawyers – Advanced; Luxembourg (LU), 8-10 November 2023

This three-day course will provide you with a concentrated, in-depth introduction into the legal system of the EU and the most important principles governing the adoption and enforcement of European Union law. Each day comprises an autonomous content module, offering the participants the possibility to follow them all, since they can be taken as a coherent pedagogical sequence, or individually.

Module 1. The EU legal system and the relationship between EU law and national law

This module studies the repartition of competences of the EU and Member States in the regulation of policy sectors, analyses in detail the typology of EU legal acts adopted at the EU level, and comments on their respective legal force and their impact on state authorities and individuals.

Module 2. Decision-making procedures for the adoption of EU law

This module explores the roles and competences of the institutions (European Commission, Council of the EU and the European Parliament) in the preparation and negotiation of legal instruments which will become binding EU law.

Module 3. The EU judicial system and enforcement of EU law

This module firstly depicts the organisation of the judicial space in the EU, clarifying the respective role of the Court of Justice of the EU (CJEU) and the national jurisdictions in the enforcement of EU legality. Secondly, it describes the structure and competences of the CJEU. Finally, it provides a detailed and practical account of the various procedures which may be brought before the Court of Justice of the European Union by EU institutions, Member States, and natural and legal persons to contest the legality of EU action to prosecute an alleged breach of EU law by a Member State, or to interrogate the Court about the meaning of an EU law provision.

Regulatory ex-post Evaluations; Online, 9-10 November 2023

This course provides an introduction to the realm of regulatory *ex-post* evaluations. It covers how to design,



manage and monitor the evaluations, regardless of whether these activities are supported by EU funds. It provides answers to the following questions:

- How can evaluation activities be managed effectively and efficiently?
- How organisations can ensure high-quality *expost* evaluations?
- How can evaluation results provide the evidence required for decision-making, and help to improve policies and programmes?

The course discusses how to ensure high-quality *expost* evaluations, by drawing on good practices and lessons learned from implementing ex-post evaluations in the European Commission. Building on this, the course provides insights into the pillars of sound evaluation design namely, the intervention logic, evaluation criteria, evaluation questions and the evaluation matrix. Moreover, the course provides participants with the opportunity to develop practical skills for managing evaluation studies and stakeholder consultation activities. Finally, the course highlights the latest developments and innovations in evaluations and methods to keep evaluations state-of-the-art in the theory and practice.

What you will learn in this course:

- How to manage an *ex-post* evaluation of a legal act;
- What are the analytical steps of an *ex-post* evaluation
- What evaluation design methodologies can be chosen to evaluate legislation.
- How to adjust expectations and choose the right shortcuts when selecting the best possible metho-dological approach (e.g. qualitative vs quantitative);
- How the European Commission system ensures transparency and quality of the evaluation work (Stakeholder consultation, regulatory Scrutiny Board)
- What is state-of-the-art in *ex-post* evaluation of legislation and what the future looks like.

Regulatory Impact Assessments; Online, 13-14 November 2023

The online course provides an introduction to Regulatory Impact Assessments (RIAs), covering their uses, methods, and functioning. It offers an overview of the current state of the art in RIA theory and practice, drawing on the approach followed by the European Commission.

The course enhances participants' ability to design, manage and communicate the results of *ex ante* Impact Assessments (IAs). It provides answers to the following questions:

- How can an impact assessment (IA) system be developed
- How can an IA system be optimised?
- How can you assess the effectiveness and efficiency of policy proposals?
- How can you ensure high-quality *ex ante* impact assessments?
- How can you use an impact assessment as a supporting tool for decision-making?

The course discusses the concept of a high-quality ex ante IA, emphasizing its needs and uses. It focuses on building participants' knowledge and skills in the main methods employed in IAs, such as cost-benefit analysis. Valuable insights into good practices are provided through lessons learned from the implementation of the European Commission Better Regulation Guidelines and Toolbox, as well as other actors like the OECD and individual countries. Additionally, the course explains how IAs can influence the EU lawmaking process. These concepts are explored through theory, examples, and practical exercises, fostering an interactive learning experience.

A Practical Guide on EU Law for Local Governments: Responding to EU Legal, Institutional and Jurisdictional Challenges; Barcelona (ES), 16-17 November 2023

Are you an official working for a municipality, region or federated entity of an EU Member State or a candidate country?

Would you like to learn about the position of sub-state authorities and administrations in the EU legal system and their responsibilities in the application of EU law? Would you like to obtain an insight into the various forums and mechanisms permitting the intervention of these authorities in the shaping of EU policies?

By attending this highly practical course, you will acquire the practical skills required to voice and



represent the interest of your local government in the process of adopting EU legal acts.

The course will also equip you with the know-how necessary to ensure their correct legal absorption and administrative application once the acts are approved, and avoid breaches of EU law which could end up to judicial prosecution.

Moreover, the course will instil in you the necessary strategies and skills to defend the interests of your local government against the EU institutions before the Court of Justice of the European Union.

Finally, the course will provide you with necessary know-how to apply for EU funding.

Stakeholder Consultation in the Context of Better Regulation; Online, 16-17 November 2023

This online course provides a comprehensive overview of Stakeholder (SH) consultation its methods, tools and processes. It demonstrates how SH consultation should be applied in practice.

It follows the sequential phases of a consultation activity, namely, the planning, design, implementation, reporting and informing. It provides an in-depth understanding of how to use the various methods and tools to consult Stakeholders. Using practical sessions including examples, case studies and exercises, this course enhances participants' capacity to draft fit for purpose and state of the art public consultation questionnaires. It discusses how to ensure that SH input can provide valuable evidence for Impact Assessments and Evaluations.

What will you learn

- How to identify all the relevant stakeholders
- How to design an effective consultation strategy to reach out to all relevant stakeholders
- How to select the appropriate consultation method
- How to set the consultation activities in the right order
- How to draft a user friendly public consultation questionnaire
- How to design short, simple and relevant questions in a neutral manner
- How to effectively communicate consultation activities and reach out to as many SHs as possible

- How to apply innovative consultation techniques to maximize public feedback
- How to perform basic analysis of data
- How to report on the findings of the consultation and inform policy making
- How to work with data protection rules

Cross-Border Civil Judicial Litigation: Service of Documents and Taking of Evidence; Luxembourg (LU), 20 November 2023

In 2020, the recasts of the EU Regulations on service of documents (Regulation no. 2020/1784) and taking of evidence (Regulation no. 2020/1783) in cross-border civil cases were approved by the EU legislator. They entered into force in August 2022.

This course proposes a comprehensive scrutiny of these instruments, highlighting the main innovations brought by their 2020 recast versions. At the same time, it will also examine these instruments in the light of the European Court of Justice case law under previous versions of those instruments and to which extent such case law remains in application.

Besides analysing the referred EU instruments, the course will also provide an overview of the equivalent instruments elaborated by the Hague Conference: the 1965 Hague Service Convention and the 1970 Hague Evidence Convention. In this manner, participants will attain a global picture of the possibilities they might encounter when taking evidence or serving documents in a cross-border context.

What will you learn:

Participants will have the opportunity to learn the following:

- the scope of application of both the Service and Evidence Regulation
- which are the main innovations brought by the 2020 updated versions of the Service and Evidence Regulations
- the different possibilities offered by the Service Regulation to serve documents in other Member States
- the Brussels I bis Regulation's alternative path to the Evidence Regulation to take evidence in another Member State



• the differences between the EU instruments on service and evidence and their counterparts of the Hague Convention.

Audit and Anti-Fraud in RRF and ESIFs 2021-2027 – Exchange of First Audit Experiences Between AAs, EC, OLAF and ECA; Zagreb (HR), 22-24 November 2023

This workshop for Audit Authorities has as main objective the exchange of experiences regarding antifraud measures in EU funding (ESIFs + RRF), conflict of interest, double financing, audit results based on Arachne or other similar tools used by AAs, and measures applied in different Member States to ensure effective and efficient control systems at the national level for the Recovery and Resilience Facility.

What will you learn:

- Changes in the 2021-2027 programming period: simplified costs and financing not linked to costs, proportionate control arrangements, annual accounts and audits, conditionalities, performance and proportional anti-fraud measures.
- Recovery and Resilience Facility (RRF): measures applied in Member States to prevent, detect and correct conflict of interest, double financing, corruption and fraud, similarities and differences of internal control systems created, and audits for RRF. In addition, how to put in place effective and efficient controls and anti-fraud measures for the RRF.
- RePowerEU and modification of National Recovery and Resilience Plans.
- Role of the European Anti-Fraud Office (OLAF) in the fraud detection and prevention in ESIF and RRF co-financed projects and programmes in the current programming period 2021-2027. The presentation of real-life fraud examples with special focus on the RRF.
- European Commission and ECA approach to ESIFs and RRF audits, audit of milestones and targets, main findings of already performed RRF audits, shortcomings and irregularities detected, and EC and ECA's upcoming RRF audits.
- Practical use of Arachne and similar tools in Member States: how to effectively use Arachne to detect irregularities and fraud in RRF? What are the advantages of data mining programmes?

- Main conflicts of interests and fraud risks in the selection process of project proposals and management verifications in the current programming period. What are the possible risks and fraud schemes in the RRF?
- Main errors and irregularities in projects co-funded by the ESIFs and significant risks related to RRF projects.

New Structural Funds Programmes and the New Regulations 2021-2027; Maastricht (NL) & Online, 28-29 November 2023

New programmes for the 2021-2027 period were delayed, but around 400 programmes have now been agreed and are being implemented. Do you know what the new programmes look like? Do you know all you need to know about the new Structural Funds Regulations, and how they compare to the last period? How have the new programmes selected priorities, activities and planned finances? What flexibilities and simplifications do they have? And how will they report progress and measure performance and impact?

This course will address these questions and examine the 2021-2027 regulations in detail. We will refer to a selection of new Programmes as well as reporting and other templates. We will also see how Cohesion Policy programmes will be coordinated with the RRF and other EU instruments.

What will you learn:

We will help you address the following questions:

- What are the key choices made by Member States for the new programmes? What does financial planning and management look like for 2021-2027?
- Where have programmes been simplified most? And how are simplified cost options being developed and used?
- How will the new Performance framework work and how do we measure progress and success?
- How will real-time reporting work?
- How are programmes improving the selection of operations? How can you "ensure that selected operations present the best relationship between the amount of support, the activities undertaken and the achievement of objectives"? (Article 73, CPR)



Competitive Dialogue and Negotiated Procedures Master Class; Maastricht (NL), 28-29 November 2023

Competitive dialogue and negotiated procedures are difficult to implement effectively but are essential for complex infrastructure and ICT projects and other public contracts where the awarding body is unsure about the best way to achieve its objectives.

In the 2014 Public Procurement Directives Competitive Dialogue and the new Competitive Procedure with Negotiation are easier to justify than in the former directives and thus are more readily available for use. The rules for the two procedures are different and the procedural rules for the Competitive Procedure with Negotiation are more detailed than the former rules of procedures including negotiation. Competitive Dialogue has also been introduced as an available procedure in the utilities sectors in Directive 2014/25/EU.

The focus of this course is related to the practical application of the 2014 Public Procurement Directives and the Directive 2014/25/EU, recognising that not all ways in which the procedure has been applied are equally effective in securing value for money for the awarding body.

The many practical questions about the effective implementation of these procedures include, for example:

- When is Competitive Dialogue a better procurement route than the Restricted Procedure or the Competitive Procedure with Negotiation?
- What justification will be needed for the use of Competitive Dialogue or the Competitive Procedure with Negotiation in the current directives?
- What do awarding bodies need to do to plan the effective use of these procedures?
- How can awarding bodies best use the flexibility which the procedures provide?

Experience shows that not all methods of using Competitive Dialogue and the Competitive Procedure with Negotiation have so far been equally effective in promoting value for money for the public sector, and objective advice on when and how to use these procedures is hard to find.

This very practical Master Class will give you the opportunity to receive case-specific advice on the issues

arising in your own procurement from our experts and from other participants.

- The role of the DPO (Data Protection Officer), the EDPS (European Data Protection Supervisor) and the national supervisory authorities;
- Severity assessment of data breaches and assurance role of the DPO (accountability, requirements and demonstrating compliance);
- Cyber security, data protection audits, privacy and digital sovereignty;
- Options and solutions for cross-border data transfer and third-country data transfers;
- e-Privacy design and impact assessment;
- Grounds for processing, including legitimate interest and consent;
- The rights of data subjects and how to handle them.
