The World Public Sector Report 2023, entitled "Transforming institutions to achieve the Sustainable Development Goals after the pandemic" is now available

The World Public Sector Report 2023 examines the role that national institutional and governance innovations

and changes that emerged during the COVID-19 pandemic can play in advancing progress towards the 2030 Agenda for Sustainable Development. The report focuses on three main questions: How can governments reshape their relationship with people and other actors to enhance trust and promote the changes required for more sustainable and peaceful societies? How can governments assess competing priorities and address difficult policy trade-offs that have emerged since 2020? What assets and innovations can governments mobilize to transform the public sector and achieve the SDGs? The report addresses them in chapters composed of short overviews followed by a set of in-depth contributions (23 in total) from a wide range of experts which examine institutional changes observed in different contexts, sectors and policy processes and explore the potential of those with a positive impact on the achievement of the SDGs to be sustained beyond the pandemic. The report aims to draw attention to institutional change as a key component of the societal transformations required to realize the 2030 Agenda for Sustainable Development. (NAPA), successfully concluded its 68<sup>th</sup> Conference and 29<sup>th</sup> General Assembly on 16-20 October 2023 at Hanoi, VietNam, with the conference theme "The Role of Public Governance in Socio-Economic Recovery and Development Towards the Sustainable Goals".

The conference welcomed prominent names from the public administration community and more than 300 scholars, practitioners, academicians, young scholars, and individuals interested in discourses about recent trends, practices, and developments in the theory and practice of public administration in the Asia-Pacific region and beyond.

#### **IPAC Annual Conference**

The IPAC Annual Conference in Ottawa saw over 1500 attendees, both in-person and virtually from across Canada, converging to explore the critical role of public administration in an era marked by social instability and rapid change. Against this background, the conference underscored the increased importance of government action.

This conference addressed critical global themes: rebuilding robust post-COVID economies, accelerating climate objectives, fortifying global partnerships, and tackling complex challenges spanning housing, immigration, economic stability, and affordability.

The sessions tackled pressing issues such as the housing crisis, AI integration including Chat GPT advances, the evolution of digital government, mental health advocacy, energy transition, and the pivotal matters of diversity and immigration. Panel of Indigenous leaders provided invaluable insights, and key takeaways as to the importance of consultation and input from the communities impacted by legislation.

The keynote session, featuring the Secretary of Cabinet of the federal government of Canada, John Hannaford, and moderated by leading consultant, Zabeen Hirji, emphasized the urgency of adapting to profound change with clarity and new working methods. Hannaford's opening address underscored the need for clarity amidst uncertainty and the significance of values and ethics as guiding compasses through change. He championed collaboration, pride in service, and the fostering of a culture valuing mistakes as learning experiences. Diversity and inclusion were reiterated as indispensable for an effective public service reflective of Canada's diverse populace.

Through in-depth discussions and focused sessions, attendees gained enriched insights and actionable strategies. They learned how to foster strengthened networks vital for steering public administration towards a more inclusive, resilient, and responsive future.

The Arab Region SDG Index and Dashboards 2023 Report, published by the Mohammed Bin Rashid School of Government in partnership with the Sustainable Development



Solutions Network (SDSN) provides a data-driven practical tool for governments, policymakers and other stakeholders to measure progress on the SDGs, and to highlight implementation challenges and data gaps, as a foundation for actions.

Practically, the Index comprises 113 indicators covering the 17 SDGs, each of which have an assigned score (0-100) and a traffic light color (green, yellow, orange, or red) to indicate performance. In addition, arrows visually indicate trends in progress towards achieving the goals for those indicators where data for multiple vears are available. Among the indicators, the 2023 Arab Region Index has 29 unique indicators that specifically reflect regional priorities and challenges. #### 1<sup>st</sup> Global Conference on Economic Diversification Research

MBR School of Government, Dubai, 2024

The MBRSG will host the 1<sup>st</sup> Global Conference on Economic Diversification in Dubai in 2024 to address methodological, theoretical, policy focused and thought-leadership outcomes based on the EDI dataset and beyond.

About the Global Economic Diversification Index (ED) -The Mohammed bin Rashid School of Government (MBRSG) published the first edition of the EDI at the World Government Summit. The EDI is built on a crosscountry, time series empirical analysis, allowing for a historical analysis of the evolution and extent of economic diversification across countries. Such an analysis represents a building block for further work to understand the macro-economic shifts, policy adjustments and strategic changes that allowed countries to either successfully diversify or, on the contrary, be held back in their path to diversification.

The inaugural edition of the EDI was based on the analysis of data from 83 countries, covering economies from all regions of the globe, income levels, and resource wealth/dependency. In 2023, the second edition of the Global EDI expanded the scope of coverage and analysis to include more than 100 countries. The third edition of the EDI is planned in 2024, with even further expanded coverage and thematic analysis.

As such, the EDI aims to fill the gap in the existing literature, data and empirical analysis: it represents a significant innovation and important addition to the analysis, discussion and policy efforts related to economic diversification. Furthermore, as a composite indicator, the EDI looks beyond trade to also include and production/output government revenue diversification, as the three dimensions forming the basis of the index. By design, the EDI is addressed as a rigorous 'reproducible research' and is solely based on publicly available data from reputable sources, following a methodology peer-reviewed by a panel of international experts. To ensure the highest levels of methodological rigor, data validity, robustness, inclusiveness, acceptance and impact on policy discourses, the MBRSG has conducted peer and expert reviews at different stages of the EDI's construction.



**Op-Ed:** "C-632/20 P, Spain v Commission: What is Kosovo for the EU? A third country? A third State? Aren't both concepts the same?"

In 2008, the National Assembly of Kosovo voted in favour of declaring its independence from Serbia. Kosovo's unilateral declaration of independence caused a schism on the international scene. While 104 States have acknowledged Kosovo as an independent State, others still consider it a part of Serbia. Nor do all EU Member States acknowledge Kosovo as an independent State; five (Cyprus, Greece, Romania, Slovakia, and Spain) have not done so. These Member States' reluctance to recognise Kosovo as an independent State was evident at the recent Committee of Ministers of the Council of Europe's <u>vote</u> to decide whether can Kosovo join the institution. Cyprus, Romania and Spain voted against while Greece and Slovakia abstained.

The existence of divergent approaches towards the independence of Kosovo among Member States has not prevented the European Union from developing strong ties with Kosovo over the years. In 2008, a few months after Kosovo proclaimed its independence, the EU launched its EULEX Mission (Council Joint Action 2008/124/CFSP) to strengthen the rule of law and the democratic functioning of Kosovo. It also appointed a special representative for Kosovo. EU-Kosovo relations reached a turning point with the signing of a Stabilization and Association Agreement in 2016 ('Stabilization Agreement'). Among its objectives, the Stabilization Agreement aims at progressively incorporating the EU acquis into Kosovo's legal order. In order to safeguard the position of those Member States which had not recognised Kosovo, Article 2 of the Stabilization Agreement clarifies that 'none of the terms, wording or definitions used in this Agreement, including and Protocols thereto, constitute the Annexes

recognition of Kosovo by the EU as an independent State nor does it constitute recognition by individual Member States of Kosovo in that capacity where they have not taken such a step'.

Case <u>C-632/20 P</u>, *Spain v Commission* provided the Court of Justice of the European Union with the opportunity to explore the status of Kosovo under EU law.



Enhancing the European Administrative Space (ComPAct): What it is (not) and what is (not) in it for the national administrations

On 25 October 2023, the European Commission presented the long awaited Communication "Enhancing the European Administrative Space (ComPAct)". The Communication proposes a comprehensive set of measures to reinforce the capacities of public administrations across the EU to implement policies, anticipate and mitigate crises and manage structural transformations.

This blog reflects on the context and scope of the Communication, and aims to explain in practical terms its implications and benefits for the Member States, what could it bring to the accession countries, how concrete actions will be funded and what is the roadmap for 2024.

**Competitive Dialogue – Bringing the dialogue to a successful conclusion** 

In Directive 2014/24/EU – the latest EU Public Procurement Directive – Competitive Dialogue was made easier to justify than in the former directives and are thus more readily available for use. It was also introduced as an available procedure in the utilities sectors in Directive 2014/25/EU.

Previous articles in this series have considered how Competitive Dialogue can now be justified and how to make the best use of the dialogue phase to enable the awarding body to achieve its objectives.

In practice, Competitive Dialogue procedures can often be lengthy, with consequences for both the awarding body, which needs to bring the dialogue phase to a conclusion to be able to call for final tenders, and for candidates for whom the dialogue phase usually involves significant costs.

One of the key decisions for an awarding body is when to close the dialogue phase and call for final tenders.

Article 30(5), Directive 2014/24/EU, states that "The contracting authority shall continue the dialogue until it can identify the solution or solutions which are capable of meeting its needs".

Article 30(6), Directive 2014/24/EU, states that "Having declared that the dialogue is concluded and having so informed the remaining participants, contracting authorities shall ask each of them to submit their final tenders on the basis of the solution or solutions presented and specified during the dialogue. Those tenders shall contain all the elements required and necessary for the performance of the project".

These legal provisions require significant practical skills for an awarding body to use them effectively.

# Recent Trends in the Case Law of the Court of Justice of the EU

Luxembourg (Luxembourg), 18-19 January 2024

This annual event will bring together leading specialists to review and comment on a number of key judgements that the Court of Justice of the European Union (CJEU) delivered in the past 12 months. The 2024 edition of the "Recent Trends in the Case Law of the Court of Justice of the European Union" will be the occasion to celebrate EIPA's longstanding contribution to the dissemination, understanding and application of EU law among legal professionals and to shed light on contemporary legal challenges, in particular those stemming from the EU's digital transition.

The conference will encourage interaction and will be an informative and pleasant networking opportunity for all participants. The conference is addressed to academics, legal practitioners from the EU institutions, legal professionals working for the Member States or as advocates, but also judges, lawyers and civil servants coming from candidate countries.

The second panel will focus on judgements that shape the action and functioning of the EU in selected and varied policy areas such as competition, consumer protection and restrictive measures. The last panel will be dedicated to decisions that pertain to our 2024 topic: the EU's digital transition. The variety of fields covered and the expertise of our speakers will provide a clear overview of the most important trends in the recent case law of the CJEU and

'I'm participating in that meeting in Brussels next week. Is it an expert group or a comitology committee?' 'I need to brief my boss about what to expect. Will the Commission ask her to vote?'

'How can I know where our issue is in the EU decision process, and what comes next?'

Simple questions, the answers to which may be complex, and yet can make your job easier. This course will get you up to speed on the essential elements of how the EU system works: the different powers that the EU has, who does what, and how you can have a role in shaping EU decisions. It is concise but thorough, and focuses in detail on EU law-making. What you will learn:

- The legal bases for what the EU can and cannot do, and the different powers that Member States have given to the EU
- The main ways in which decisions are taken, i.e. the toolbox of EU policy-making
- The hierarchy of EU law and the differences between legislative acts, implementing acts (the world of 'comitology'!) and delegated acts using topical case studies
- The ordinary legislative procedure and how 'trilogues' work
- The decision-making procedures within the Commission, the Council and the European Parliament, and the ways in which national officials and other stakeholders fit into the policy-making process

#### Course methodology:

This course is based on 'blended learning' methodology with both online and in-person interaction prior, during and after the course. Throughout the course, there is plenty of time for questions and opportunity for discussions.

The course methodology was updated to include:

- Additional interactive online elements to facilitate participants' independent learning

The CAF Criterion 1 deals specifically with leadership, covering four sub- criteria to be evaluated. The aim of this course is to deeply explore and master the CAF through robust leadership engagement and full commitment from the onset of CAF implementation.

Allow us to elevate your understanding by merging leadership engagement and agile methodologies for the efficient implementation and monitoring of CAF action plans. Why is this approach pivotal? It ensures that leaders possess comprehensive insights into the current status, enables staff to operate within an inclusive and transparent environment and ensures full organisational awareness across all levels and sectors.

Leadership mastery: Cultivate a culture of continuous improvement, resilience and adaptability within your organisation.

You will possess the skills to develop agile action plans, navigate complex challenges and inspire your teams to excel. Not just theory, this course offers actionable strategies for immediate implementation, so that you can apply new-found knowledge in your professional context right away.

Q&A sessions with guest speakers will encourage interaction and in-depth discussions.

#### Recent Developments in European Public Procurement and Case Law

#### Maastricht (Netherlands), 4-5 June 2024

This course will provide you with an update on the legal issues in European public procurement. Legal experts and practitioners will explain in an accessible manner the recent legal developments and recent case law in the field of European public procurement.

The first part of the course will concentrate on recent developments in public procurement at European level and the second part will be devoted to recent case law.

You will receive an insight into the recent jurisprudence of the General Court. This case law relates to challenges to contract awards bv the EU institutions/agencies/bodies and is based on procurement under the Financial Regulation. Special attention will be given to the recent case law of the Court of Justice of the EU (CJEU) in the field of procurement. In addition, the essence of the remedies directives and the related case law will be presented and interpreted for you.


