2. Peer exchange with voluntary national review countries and voluntary local review cities on experiences and promising practices in implementing Sustainable Development Goals 16 and 17.
3. Institutions, climate action and environment.
4. Principles of effective governance for sustainable development.
5. Public sector workforce matters.
6. Public financial management.
7. Digital government.
8. Institution building in fragile and conflict-affected areas.

The 2024 UN Public Service Forum and Awards Ceremony took place in Incheon, Republic of Korea, from 24 to 26 June 2024, under the theme Fostering Innovation amid Global Challenges: a Public Sector Perspective. The Forum was co-organized by the United Nations Department of Economic and Social Affairs (UN DESA) through its Division for Public Institutions and Digital Government (DPIDG) and the Ministry of the Interior and Safety of the Republic of Korea (MOIS). The 2024 United Nations Public Service Forum focused on the role of fostering innovation and transformation in the public sector, with a view to enhancing the current and future capabilities of public administrations so they are readied to be more adaptative, anticipatory, agile, inclusive, and responsive in meeting development objectives amid complex global challenges. The Forum provided a platform for Ministers, senior level decision-makers, and working level public servants to reflect upon and develop the skills needed to devise tangible actions to foster innovation and transformation at the local and national levels. UN DESA in collaboration with the Alliance of Small Island States (AOSIS) and the Permanent Mission of the Principality of Monaco to the United Nations organized a side event during the Second Preparatory Committee Meeting of the 4th International Conference on Small Island Developing States. The event took place on 2 April 2024 and featured experts from international financial institutions, UN entities and governments of SIDS and partners. The objective of this side event was to provide an opportunity for an expert-level discussion on concrete steps to support a sustainable ocean-based economy in SIDS. Global Forum on Data Governance and Digital Transformation

Data and digital data governance in the public sector have become increasingly important in Governments' modus operandi and real-world applicability. Data are now integral to every sector and function of government—as essential as physical assets and human

resources. Much of the operational activity in government is now data-driven or data-centric, and many Governments would find it difficult, if not impossible, to function without data.

This Global Forum sought to address existing challenges and gaps in national digital data governance, data management and cooperation, focusing on enhancing the institutional capacities of countries to utilize, manage and govern data in a comprehensive, objective and evidence-based manner, through regional and global cooperation. The aim was to build awareness and develop institutional capacities in building national data governance frameworks in developing countries, especially those in Africa and the Asia Pacific region. Digital Government Transformation Webinar: Driving the 2030 Agenda for Sustainable Development and the African Union Agenda 2063

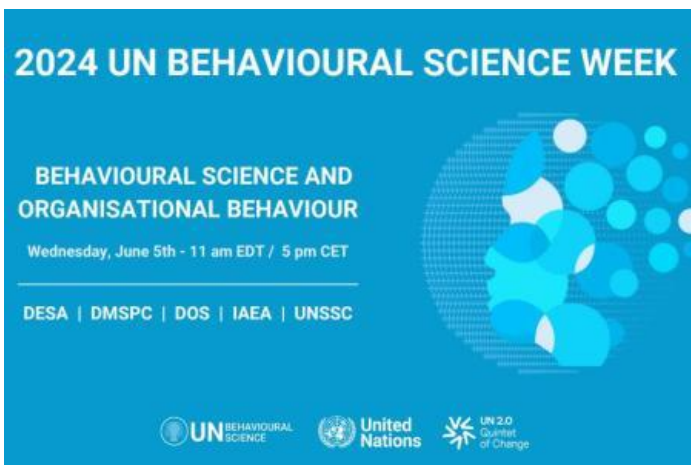

Within the framework of the UN Behavioural Science Week, a session on Behavioural Science and

Organisational Behaviour was organized by UN DESA, DOS, DMSPC, IAEA and UNSSC on 5 June. The session highlighted experiences from UN DESA, DOS, DMSPC, IAEA and UNSSC applying behavioural science to change the way organisations work. It included discussion about the application of BeSci in operations, changing mindsets in public institutions, fostering UN values and behaviours, and organisational culture in the area of atomic energy. This session was structured around four lightning talks to illustrate how behavioural sciences is being applied in the UN to promote changes in the way organizations perform. Each UN entity highlighted its initiative by focusing on key dimensions, who it partnered with and main results. 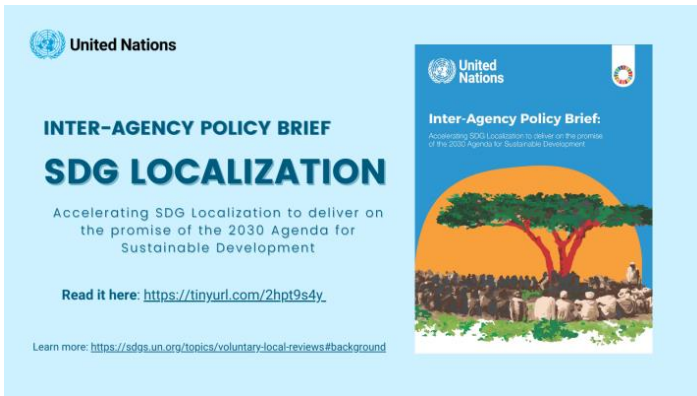
Webinar Series on Effective Governance and the Quintet of Change for the Implementation of the Sustainable Development Goals

IGF 2024 in the Spotlight at Geneva Meetings

In preparation for the [19th annual Internet Governance Forum \(IGF\)](#), to take place in the Kingdom of Saudi Arabia in December 2024, open consultations with stakeholders and a meeting of the IGF’s [Multistakeholder Advisory Group \(MAG\)](#) were convened on 26-28 June at the UN Office in Geneva.

Over the course of [three-day deliberations](#), the MAG – a regionally diverse, forty-member body which is co-chaired by the Kingdom of Saudi Arabia this year – took a final decision on the workshop sessions that will be included in the IGF 2024 programme, selecting 90 out of more than [200 proposals](#). The workshops will be on the [themes](#) of Harnessing innovation and balancing risks in the digital space; Enhancing the digital contribution to peace, development, and sustainability; Advancing human rights and inclusion in the digital age; and Improving digital governance for the Internet We Want. Main sessions will focus on protecting the public core of the Internet, bridging digital divides, Internet and election integrity, and the IGF role in digital governance.

During open consultations, representatives from ITU, the Office of the Secretary-General’s Envoy on Technology, UN ECA, UNESCO, UNIDIR and UNJSPF, among other international organizations like OECD and the Council of Europe, gave updates on their digital work and areas of synergy with IGF.

The [WSIS Forum](#) at the end of May 2024, also in Geneva, hosted two IGF sessions and an exhibition stand promoting the 2024 annual IGF and the rich array of activities the Forum coordinates year-round. Participants learned about IGF [youth](#) and [parliamentary](#) capacity development, as well as the more than 170-strong network of grassroots [National, Regional and](#)

Canada relies on immigration for economic development and growth. Recent immigrants in Canada are generally healthier than the Canadian-born population, a phenomenon known as the Healthy Immigrant Effect. However, the health advantage of immigrants diminishes over time, with studies showing that after 10 years in Canada, immigrants have similar or poorer health than the Canadian born population. Ensuring the long-term health and well-being of immigrants is crucial for Canada's health system and economic development. On 12 June, IPAC and Deloitte Canada cohosted a panel on key topics and concepts surrounding Canada's housing supply challenges. Governments have announced new programs, policies, and funding over the last twelve months to accelerate the supply of housing. With a growing pipeline of approved housing units to be constructed across the country and a ten-year target of 3.87 million net new homes, Canada's current and impending gap in skilled trades becomes more real. On June 28, 2024, the Institute of Public Administration of Canada (IPAC), in collaboration with Microsoft, hosted an event titled Navigating AI in the Public Sector. Over 2400 participants joined us for this session.

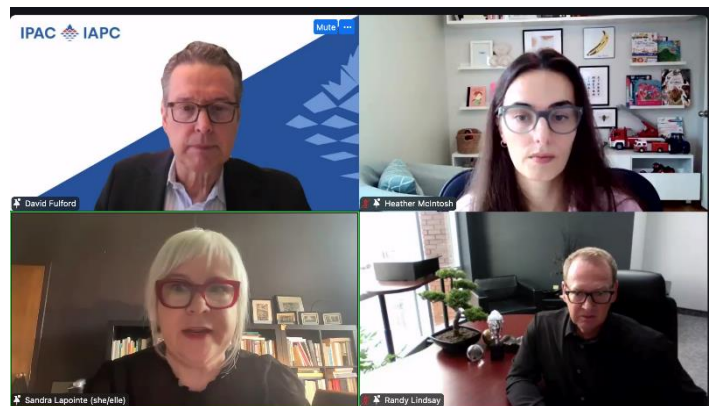
The event focused on the transformative potential of Generative AI in enhancing productivity, efficiency, and streamlining processes within the public sector. The panelists included Christiane Fox (Deputy Clerk of the Privy Council), Dominic Rochon (Deputy Minister and Chief Information Officer of Canada), Catherine Fortin LeFavre (Canadian Chamber of Commerce), and Marlene Floyd (Microsoft Canada). They provided invaluable insights into the economic opportunities and real-world applications of AI.

Key Messages from the event:

- **Economic Opportunities of AI:** Panelists highlighted that embracing AI can lead to significant economic benefits, including cost savings, improved efficiency, and enhanced decision-making capabilities. Leveraging AI tools can help the public sector drive innovation and improve service delivery.

- **Public Service's Role in AI Leadership:** It was emphasized that the public service will play a crucial role in positioning Canada as a global leader in AI. By adopting AI technologies and fostering a culture of innovation, the public sector can set a precedent for other industries and countries.
- **Real-World Applications and Use Cases:** The event showcased several real-world applications of AI within the public sector, from improving workflow efficiency to enhancing citizen engagement. These examples demonstrated the practical benefits of AI and inspired participants to explore AI solutions within their own organizations.

Three key messages from the event discussions:

1. **Aligning SES with Organizational Values:** Experts emphasized that integrating SES with organizational values is crucial for building stronger, more cohesive teams. When SES are aligned with core values, teams function more effectively, fostering a positive work environment and enhancing overall productivity. This alignment helps in creating a culture of trust and mutual respect, essential for high performance.
2. **Effective Recruiting Practices:** The importance of strategic recruiting practices to attract candidates with strong SES was a major focus. Attendees learned how to identify and recruit individuals who not only have the necessary technical skills but also possess the social and emotional skills that drive team collaboration and success. Techniques for evaluating SES during the hiring process were discussed, providing attendees with actionable strategies to improve their recruitment efforts.
3. **Measurable Assessment and Support Tools for SES:** The event highlighted the need for measurable assessment tools to evaluate and support SES among employees. Participants discovered various methods and tools to assess SES, ensuring employees can thrive in their roles. These tools are vital for ongoing development and support, helping organizations maintain a resilient and productive workforce.

The event offered participants a wealth of knowledge on the critical role of SES in today's workplace. By focusing on these skills, organizations can build resilient, high-performing teams that drive productivity and success in an increasingly digital world.

128th Forum of the National Council of Secretaries of Administration

Bahia hosted the 128th Forum of the National Council of Secretaries of Administration (Consad), on 18 to 10 April.

Held for the first time in Salvador, Bahia’s capital, the event brought together 400 public servants from all over the country, including secretaries of administration from 23 states and the Federal District, the governor of Bahia, Jerônimo Rodrigues, and the host of this edition of the event, the secretary of administration of Bahia, Edelvino Góes.

The main challenges of public management in Brazil – in areas such as hiring and managing people, controlling expenses, innovation and partnership models with the society – were discussed at the event's discussion table.

During the meeting, an electronic platform containing a collection of 2,500 scientific papers from the 12 editions of the Consad Congress on Public Management was launched. The tool will be accessible on the Consad website (www.consad.org.br). It will function as a repository of scientific works, containing strategic knowledge for strengthening public administration, as well as innovations and efficient practices.

Initiatives such as the launch of a Good Practices Platform were also announced, allowing the sharing between the public agencies of successful initiatives in the most diverse areas.

Another resolution was the technical cooperation agreement between Consad and the Secretariat of Administration through the International Center for Innovation and Exchange in Public Administration (CIIAP).

The objective of the technical agreement between CIIAP and Consad is exchanging initiatives and projects aimed at encouraging innovation and improving public management that is anchored in the Sustainable Development Goals.

The European Court of Auditors (ECA) has recently published the special report 28/2023, on public procurement in the EU. In it, the Court makes a wide-ranging critique of the state of competition for public procurements in the EU and its perceived lack of achievement of the 2014 reform objectives during the period from 2011 to 2021.

In this blog we summarise the main conclusions, the answer by the Commission so far, and the potential impacts it may have according to the most recently published academic articles.

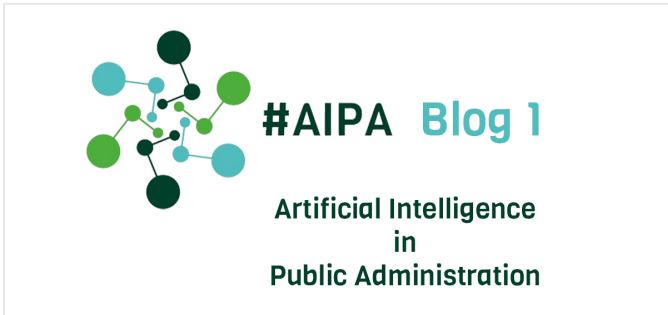

Why AI Literacy is Essential for Public Administration?

Keeping up to date on advancements in Artificial Intelligence (AI) is no easy task. In the span of six months, AI can evolve more rapidly than many other sectors do in decades. The need for key stakeholders to keep a close eye on advancements in this field is crucial to ensure AI developments are aligned with the interests and safety of humans.

This blog highlights the importance of AI literacy for public officials, noting that their role in policy-making, public service delivery, and regulatory compliance requires a thorough understanding of AI. 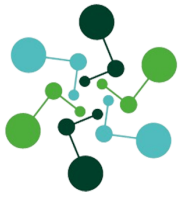
The Long Delay in the Application of the 2018 Reform of the European Electoral Act: Is it all about the thresholds?

In 2018, the Council approved Decision 2018/994 to reform the European Electoral Act (the '2018 reform'), which had to be subsequently approved by Member States observing 'their respective constitutional requirements' (Article 223(1) Treaty on the Functioning of the European Union). This reform brought changes concerning the electoral thresholds that political parties have to reach to obtain Members of the European Parliament (MEPs) in some Member States.

To the present day, the 2018 reform remains unapplied because one Member State, Spain, has not yet ratified it. Germany did so only in March 2024. This delay in ratifying the reform derives from the challenges that these two Member States encountered when implementing the new threshold regime. This post aims to provide an overview of the difficulties in approving the 2018 reform, focusing on the controversies surrounding the new electoral thresholds regime.

This blog discusses the 2018 reform of the European Electoral Act and the challenges in its implementation, focusing on the mandatory electoral thresholds for the allocation of seats in the European Parliament.

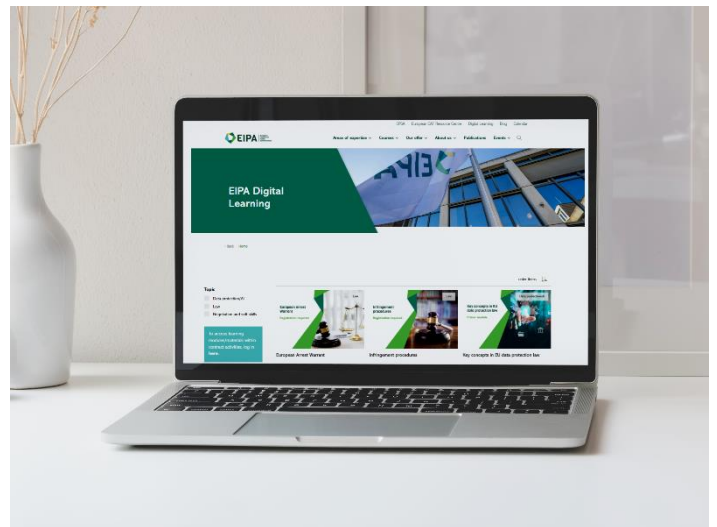

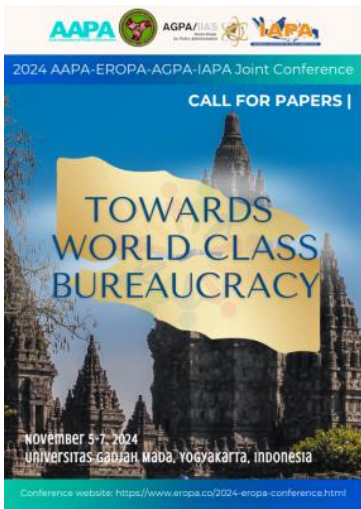

Introduction to EU Asylum and Migration Law Luxembourg, 18-19 September 2024

The course addresses two complementary areas of EU law. Firstly, it explains the policy considerations and legal concepts related to asylum law as developed in the EU’s Common European Asylum System (CEAS). Secondly, the course addresses other aspects of the European Union’s Area of Freedom, Security and Justice relevant for understanding EU migration law in the broader sense (Schengen, human smuggling, regular migration of third country nationals).

The training will explain the challenges of policy formulation and regulation of asylum matters, and it is within this context that the course will address the EU’s challenges in responding to the large-scale movements of 2015-2016, as well as the EU’s approach to tackling the recent Ukrainian refugee crisis. A look at the New Pact on Migration and Asylum will reveal if it can serve as a new start. The much broader questions about the EU’s future, identity and responsibility will also be addressed.

What will you learn:

At the end of this course you will have a good understanding of:

- EU legal and policy concepts related to asylum and migration.
- The challenges of balancing fundamental rights protection of individuals with the principle of solidarity among Member States and the policy, legal and jurisprudential responses to these challenges.

The course will combine presentations by experts and group discussions of concrete examples from the case law.

Data Protection in the Healthcare Sector: Challenges and Opportunities
