Effective Governance and the Quintet of Change for the Implementation of the Sustainable Development Goal: Webinar on Leaving No One Behind,



This webinar, held on 13 November 2024, examined some of the elements of leaving no one behind and innovative solutions that have used digital technologies for the achievement of the Sustainable Development Goals. Bridging the digital divide is a critical priority for ensuring that no one is left behind, including the development of affordable technology, skills and availability of productive services. Digital inclusion requires collaboration and cooperation across government and private sector organizations. A whole-of-government and whole-of-society approach is needed to drive digital inclusion initiatives that ensure equitable access to digital technologies and opportunities for all citizens, leaving no one behind. Leaving no one behind is also one of the principles of effective governance for sustainable development, which were developed by the Committee of Experts on Public Administration (CEPA) and endorsed by ECOSOC in 2018. The webinar also examined some of the strategies to operationalize the principle of leaving no one behind as articulated by

CEPA in its principles of effective governance for sustainable development. The webinar was part of the Webinar series on Effective Governance and the Quintet of Change for the Implementation of the SDGs. More information is available [here](#).

The Regional Symposium on Effective Governance is a UN DESA annual event in the Asia and the Pacific region and beyond. It seeks to raise awareness of critical public governance issues, examine current and future trends, and provide innovative approaches and new methodologies to support United Nations Member States in developing their capacities to accelerate the implementation of their commitments toward achieving the 2030 Agenda for Sustainable Development.

Strengthening Institutional Capacities in Africa for Effective Implementation of the 2030 Agenda for Sustainable Development and AU Agenda 2063



UN DESA and AU/APRM have been partnering to support African countries in strengthening governance capabilities since 2019, using the UN principles of effective governance for sustainable development as a foundation for action.

This workshop was held in Cape Town, South African, from 24 to 16 October 2024. It aimed at supporting African countries in exploring development of concrete, tangible outcomes and plans of action for building effective, accountable and inclusive institutions that contribute to implementation of the 2024 Ministerial Declaration of the HLPF, the Pact of the Future and the second 10-year implementation plan of AU Agenda 2063 with a view to accelerating the achievement of national aspirations and objectives while responding to the related national development priorities identified by countries. Global Symposium on Data and Digital Governance in Shanghai and Deqing



This Global Symposium, held in China, was organised under the scope of the UN Peace and Development Fund’s (UN PDF) capacity development project on Developing institutional capacities for digital data management and cooperation to advance progress toward the Sustainable Development Goals. It addressed the existing challenges and gaps in implementing national digital data governance frameworks among countries, through enhancing the institutional capacities of countries to utilize, manage and govern data in a comprehensive, objective and evidence-based manner, through regional and global cooperation. The aim was to build awareness and develop institutional capacities in building national data governance frameworks in developing countries, especially those in Africa and the Asia Pacific region. Expert Group Meeting towards New Standards of Excellence for Public Administration Education and Training



The United Nations Department of Economic and Social Affairs (UN DESA), through its Division for Public Institutions and Digital Government (DPIDG) and its Project Office on Governance (UNPOG), and the International Association of Schools and Institutes of Administration (IASIA), organized an Expert Group Meeting (EGM) of the UN DESA/IASIA Global Task Force: Towards New Standards of Excellence for Public Administration Education and Training. The EGM took place at United Nations Headquarters from 14 to 15 October 2024.

The objective of the EGM was to discuss and agree on new and updated Standards of Excellence for Public Administration Education and Training based on the contributions of over 1000 experts from around the globe who met through various global and regional workshops, and an online survey that was administered in five languages. The Standards of Excellence were

Public Sectors and Public Services for Sustainable Development International Seminar



The Public Sectors and Public Services for Sustainable Development International Seminar hosted by the Shanghai Academy of Social Sciences, Division for Public Institutions and Digital Government, UN DESA, and organized by the Institute of Information Sciences, SASS, was held in at the Shanghai Academy of Social Sciences on November 12, 2024. Eighteen experts and scholars from the Division for Public Institutions and Digital Government, UN DESA, International Institute of Administrative Sciences, universities and research institutions in the United Kingdom, Japan, Republic of Korea, the Philippines and Hong Kong, China, Beijing and Shanghai delivered keynote speeches. More than 70 people attended the meeting.

Wu Xueming, Vice President of the Shanghai Academy of Social Sciences, delivered a welcome speech. He expressed his sincere gratitude to UN DESA for its long-term trust and support for the Shanghai Academy of Social Sciences in co-organizing seminars and jointly compiling and publishing important reports. He expected the experts to actively share experiences, exchange ideas in depth, and strengthen cooperation around the theme of public sectors and sustainable development and focus on the vivid practice of digital government construction, so as to provide forward-looking strategies and suggestions for providing public services and contribute wisdom and strength to jointly building a prosperous, just and sustainable world.

Mr. Zhu Juwang, Director of the Division for Public Institutions and Digital Government, and Acting Director of the Division for Sustainable Development Goals, UN DESA, pointed out that the public sectors play an important role in such key areas as alleviating poverty and hunger, promoting education and public health, creating good investment and job opportunities, protecting the ecological environment and addressing climate change. He expressed gratitude to the SASS for the Chinese translation of the United Nations World Public Sector Report 2023. The Chinese version of the World Public Sector Report 2023 was released at this seminar and is the fourth time that the Institute of Information Sciences has undertaken the task of translating and publishing the Chinese version.

Dr. Sofiane Sahraoui, Director General of the International Institute of Administrative Sciences (IIAS), Professor Peter Fong, President of the Hong Kong Public Administration Association, and Professor Zhou Fengqi, Director of the Institute of Ecology and Sustainable Development, SASS, delivered keynote speeches on

Dhaka International University-SANPA-IOM international conference on Sustainable Development in South Asia: Where Do We Stand



This conference, held from 25 to 27 October 2024 in Dhaka, was attended by more than 250 scholars, researchers, practitioners, UN experts, PEP (politically exposed persons), diplomats, and senior policymakers from 15 countries and 90 universities and institutions. This conference provided the maiden opportunity for the SANPA EC to interact physically for the first time since its inception in 2020. The conference analyzed and dissected several aspects of sustainable development, and the speakers emphasized over and over again that there must be cooperation and partnerships between South Asian nations to achieve sustainable development. They also underscored the need to revamp the SAARC to strengthen multilateralism in resolving challenges. One of the key takeaways is that the global order must be just, inclusive and pro-poor.

Inaugural Global Conference on Economic Diversification



The inaugural Global Conference on Economic Diversification took place on October 31, 2024, at the Mohammed Bin Rashid School of Government (MBRSG) headquarters in Dubai. Organized by MBRSG, the event brought together experts from universities, policymaking institutions, and international organizations to explore policies and research on economic diversification.

8th edition of the African Forum of Territorial Managers and Training Institutes targeting the Local Government



Building on MBRSG's Economic Diversification Index (EDI), the conference featured a keynote address by Alia bint Abdullah Al Mazrouei, UAE Minister of State for Entrepreneurship. She highlighted the UAE's success in economic diversification, with non-oil sectors contributing 74% of GDP, and emphasized initiatives in renewable energy, AI, biotechnology, and advanced manufacturing under the "We the UAE 2031" vision.

The event welcomed 150 participants from 30 countries, with 19 academic papers accepted for publication. Day one featured panels on Gulf economic strategies, global challenges, and green financing, as well as discussions on economic complexity, institutional quality, and decarbonization. The conference continued with additional paper presentations on November 1, 2024.

Certified Artificial Intelligence Ethics Assurance in Financial Ecosystems

MBRSG Led Session on Integrating the Global South in Global AI Governance at IGF 2024



The Mohammed Bin Rashid School of Government (MBRSG), in collaboration with the IEEE Standards Association (IEEE SA) and the DIFC Academy, is organizing the 3rd batch of the Certified Artificial Intelligence Ethics Assurance in Financial Ecosystems program from February 17-20, 2025, at the MBRSG premises in Dubai.

This Executive Education program focuses on addressing AI ethics assurance in Autonomous Intelligent Systems (AIS), while enhancing business models for both government and private sector entities, specifically emphasizing AI applications in financial ecosystems.

The program is tailored for professionals eager to learn to assess AIS for ethical conformity, including privacy, transparency, accountability, and algorithmic bias—key criteria under the IEEE CertifAIEd Program. Completion of this course marks a critical step toward becoming a globally recognized IEEE CertifAIEd Authorized Assessor.

The Mohammed Bin Rashid School of Government (MBRSG) organized a session titled Integrating the Global South in Global AI Governance at the Internet Governance Forum (IGF) 2024, held in Riyadh, Saudi Arabia, from December 15 to 19, 2024. Moderated by Dr. Fadi Salem and including Roeske Martin, Google, Deniz Susar, UN DESA, Gilles Fayad, IEEE, Nibal Idlebi, ESCWA and Sherifa Sherif, Egypt, this session explored key questions surrounding inclusive AI governance. Discussions focused on defining goals for inclusion, the roles of multinational organizations, local governments, and private sectors in fostering equitable participation, and strategies to ensure fair distribution of AI benefits while mitigating risks, particularly for the Global South. The session aimed to address the development of unbiased global AI governance frameworks that reflect the diverse needs of underrepresented regions.

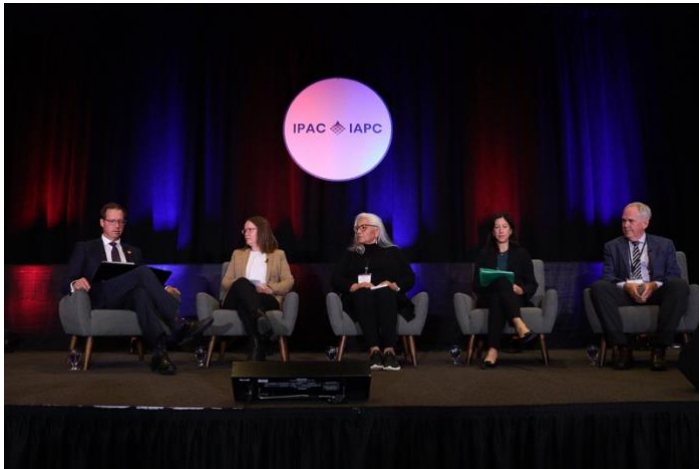
This initiative aligns with IGF 2024's overarching theme, Building our Multistakeholder Digital Future, highlighting sustainable and inclusive digital development.

IPAC Annual Conference 2024



The 2024 IPAC Annual Conference took place from October 2–4 2024 in Winnipeg, bringing together leaders from public service across Canada. This event featured keynote addresses, interactive workshops, and networking opportunities, equipping participants with tools to drive change in their organizations.

Speakers shared perspectives on diversity, crisis management, AI, and Indigenous governance, emphasizing reconciliation and inclusive policymaking.

The conference also celebrated public service excellence through the IPAC Awards, recognizing individuals and organizations for significant contributions to public administration.

Key Messages from the Event:

1. Indigenous Governance: Advancing Reconciliation

A significant focus of the conference was on Indigenous governance. Chief Gordon Bluesky stated, “There is no university where you can learn how to develop relationships across nations and governments. It’s about spending time with leaders and building relationships.” Kathleen Bluesky added, “The development of our land reflects the history and culture of our First Nations.” The session emphasized partnerships rooted in mutual respect to advance reconciliation.

2. Leadership in Challenging Times

Public servants were called upon to think creatively and collaboratively to navigate the complex challenges of today’s world. Sarah Thiele (Deputy Clerk and Associate Secretary to the Cabinet, Privy Council Office) urged attendees to embrace problem-solving, mentioning, “We

need solutions-oriented creativity to meet citizens’ needs.” Discussions during the session highlighted practical strategies for fostering resilience and driving impactful change within the public sector.

Navigating AI: A Practical Guide for Public Servants



IPAC, in collaboration with Microsoft, is launching its highly anticipated free AI Training Series designed to equip Canadian public servants with generative AI skills. This four-part workshop, beginning November 2024, explores the fundamentals of AI, prompt engineering, productivity tools, and public sector uses. The program is tailored to help public servants leverage AI to enhance service, streamline operations, and drive innovation across government.

The series has over 4,000 participants attending in the first Cohort, led by David Marotte (Quebec Leader, Data and Artificial Intelligence, KPMG)

Each workshop focuses on essential aspects of AI relevant to the public sector. The first workshop begins with an introduction to AI literacy, providing participants with a foundational understanding of AI. The second workshop dives into the art of prompt engineering, offering effective strategies for interacting with AI to optimize outcomes and improve workflow efficiency. The third workshop explores how tools such as Microsoft 365’s Copilot AI assistant. The series concludes with an analysis of real-world AI use cases in government, demonstrating how these applications can drive significant value and impact across various levels of the public sector.

Public servants can register for future sessions scheduled in early 2025, with plans for additional cohorts in the spring. These workshops represent a pivotal step toward building an AI-ready public sector. [Event link.](#)

Participants will explore key themes, including Values and Ethical Foundations for Public Servants, Ethical Decision-Making, and Protections and Responsibilities, to ensure they are prepared to uphold the highest standards of integrity in their work.

The course featured guest speakers, including William Bromm, (Former General Counsel and Special Advisor to the Ontario Government), and Christiane Fox, (Deputy Clerk of the Privy Council). These experts shared real-world insights, offering valuable perspectives on the ethical challenges public servants face and strategies for addressing them effectively.

Upon successful completion, attendees earn digital credentials from IPAC and Schulich ExecEd, certifying their expertise in ethical governance and demonstrating their commitment to professional excellence.

This program represents a unique opportunity for public servants to enhance their ethical decision-making skills. Whether facing situations involving data breaches, conflicts of interest, or whistleblower protections, participants will leave equipped to handle the most challenging scenarios with integrity and professionalism. 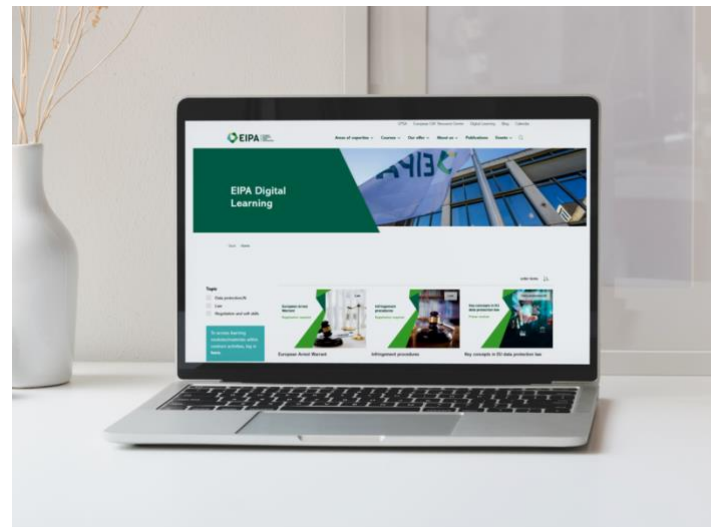

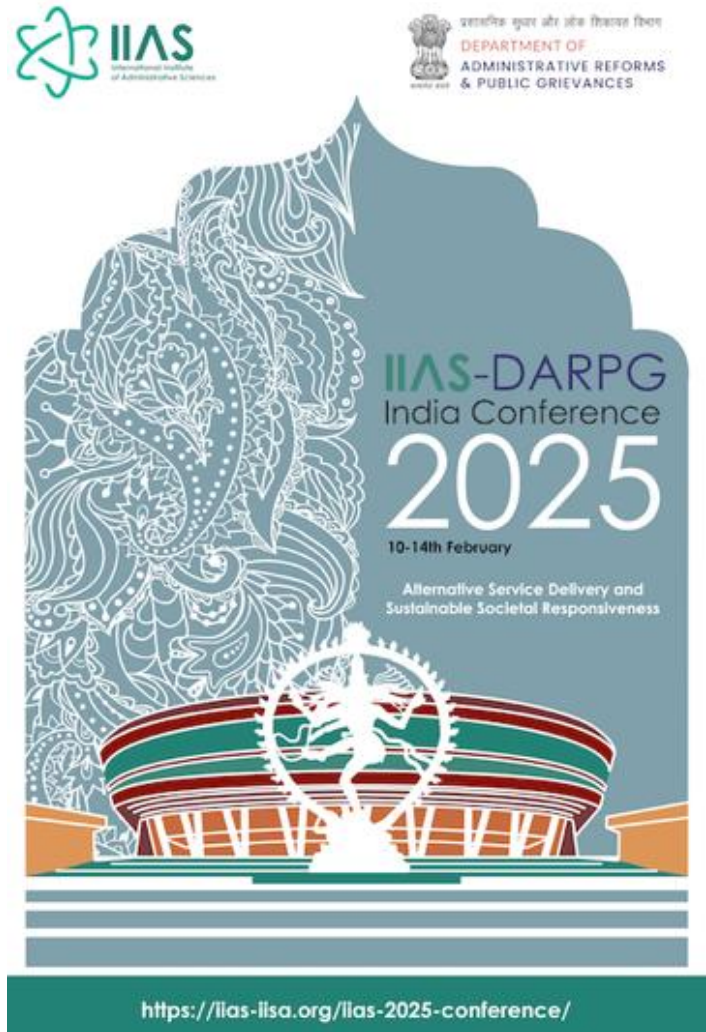
