## Advanced Approaches to Public Sector Innovation by Design

Event Type: Virtual Training Program

Date: May 5, 12, 20, 26, 2025

This four-part program—developed by IPAC in partnership with the Danish Design Center—guided participants through public sector innovation practices rooted in service design, sustainable leadership, mission-led approaches, and systems change. Each session featured global experts from Denmark and a Canadian public service cohort.

### Key Messages:

- Design leadership is essential to foster ethical, citizen-centered innovation.
- Public service challenges benefit from structured, design-based problem-solving methods.

Event Type: Virtual Webinar  
Date: April 24, 2025

This session focused on how technology and data can enhance emergency preparedness and response in Canada. Presented with Deloitte, the discussion covered real-time information sharing, AI-supported planning tools, and the evolving role of digital communications during crises.

#### Key Messages:

- Modernizing disaster management requires interoperable tech systems across jurisdictions.
- Predictive analytics and geospatial data are critical for proactive risk mitigation.
- Training and investment in digital literacy are vital to ensure equitable response capacity.



### Navigating the Future of Public Employment Services

Event Type: Virtual Webinar  
Date: June 12, 2025

In partnership with Deloitte, IPAC hosted this forward-looking webinar to explore the key drivers reshaping global employment services. Speakers Alia Kamlani and Dr. Wilem Pieterse outlined how digital technologies and demographic shifts are transforming workforce ecosystems.

#### Key Messages:

- Governments must reimagine employment services through digital platforms and data strategies.
- AI-driven systems can personalize services but must be implemented equitably.
- Public-private collaboration is essential for resilience in employment systems.

### Navigating AI: A Practical Guide for Public Servants

Event Type: Workshop Series

Date: April 15 – May 6, 2025

This four-part virtual training series, hosted by IPAC in collaboration with Microsoft, equipped Canadian public servants with core competencies in generative AI. Over four sessions, participants explored topics such as AI literacy, productivity tools, prompt engineering, and sector-specific use cases.

Featuring thought leaders from Microsoft, KPMG, and the Canadian public service, the workshops combined foundational knowledge with real-world applications, empowering over 20,000 public servants since November to integrate AI into their work.

#### Key Messages:

- Public servants must lead with a clear understanding of AI risks and opportunities to serve the public interest effectively.
- Prompt engineering is a core skill to increase efficiency and critical thinking when using generative tools.
- Real-world examples from Canadian and international public service use cases help translate AI theory into impact.



### Integrity First: Values and Ethics for a Modern Public Service

Event Type: Webinar

Date: May 27, 2025

Held in partnership with York University's Schulich School of Business, this 3-hour session brought together Paul Mochrie (City of Vancouver) and Dr. Zachary Spicer to examine the role of values and ethics in the evolving landscape of public administration.

#### Key Messages:

- Modern ethical dilemmas require a proactive, reflective public service.
- Public trust is built through transparency and adherence to shared principles.
- Ethics must be embedded in leadership training and operational practice.

### Launch of Exploring the Future of Public Sector Work - Generative AI Adoption Amongst Dubai Government Employees Report during Dubai AI Week 2025



As part of Dubai AI Week 2025, the Mohammed Bin Rashid School of Government (MBRSG), in strategic partnership with the Dubai Government Human Resources Department (DGHR), launched a landmark report titled Generative AI Adoption Amongst Dubai Government Employees. This timely research initiative aligns with Dubai's ambition to become a global leader in innovative, AI-driven governance.

The report offers the most in-depth look to date at how generative AI tools—such as ChatGPT, Gemini, Claude and Copilot—are being used, perceived, and understood within the public sector. Drawing on survey responses from over 2,400 government employees, in-depth interviews with Chief AI Officers from five key departments, and an occupational exposure analysis based on global AI benchmarks, the study provides actionable insights for policymakers.

Findings highlight a growing awareness of generative AI and its transformative potential, while also underscoring gaps in training, trust, and governance. The report calls for a unified approach to skill development, ethical frameworks, and cross-government collaboration to ensure responsible and impactful adoption.

The launch event featured a dynamic panel discussion exploring adoption trends, benefits, challenges, training needs, trust, and occupational impact—reinforcing the need for future-ready strategies to guide AI integration across the public sector.

Government (MBRSG), in partnership with Google.org, launched the groundbreaking report *The Artificial Intelligence & SMEs Ecosystem in the UAE* during the Dubai AI Week 2025. This timely research explores the evolving role of AI in enhancing the innovation, competitiveness, and resilience of small and medium-sized enterprises (SMEs)—a cornerstone of the UAE's economic diversification agenda.

The research is part of a wider regional project covering 10 Arab States. Drawing on expert interviews, policy analysis, and ecosystem mapping, the report offers an evidence-based assessment of the current state of AI integration among SMEs. It examines both the opportunities and challenges facing business owners, investors, policymakers, and ecosystem enablers in scaling AI adoption across various sectors.

The research highlights several critical barriers, including limited access to data, lack of technical capabilities, and funding constraints. At the same time, it showcases successful case studies of AI-driven innovation taking place across the UAE. To foster a thriving AI-SME ecosystem, the report calls for strengthening digital infrastructure and data-sharing frameworks, expanding capacity-building and funding programs for startups, promoting ethical and responsible AI practices among small businesses, and facilitating multi-stakeholder partnerships to accelerate adoption.

The report was launched during a panel session featuring leaders from the public and private sectors, who discussed practical pathways to enhance SME competitiveness and innovation through AI. The session reaffirmed the UAE's commitment to enabling AI-powered economic resilience.

### 33rd NISPAcee Annual Conference – Summary report

Conference main theme:

**Polycrisis and multi-level governance: Impacts, lessons learned, challenges and opportunities**

The polycrisis have uncovered insufficient capacities of many governments. The volatile nature of these polycrisis have tested the flexibility of policy making at various levels. A closer look at the CEE region during this period was discussed to understand seriousness of the polycrisis. With democratic backsliding, visible loss of citizens' trust in their governments, a shift from consolidated democracy and decentralisation towards attempts to use authoritarian approaches and centralisation tools, financial instability and growth of government debt, deterioration of fundamental principles like rule of law, transparency or accountability, an unprecedented success of populist and anti-system voices, unreadiness to deal with a diverse group of hoaxes – many governments in the CEE region have struggled and have not found how to effectively cope with the polycrisis yet. On this matter, it is necessary to analyse the polycrisis, its effects as well as impacts, and to understand them. Despite the fact that we still do not see the end of the polycrisis, researchers and scholars should be leaders from the perspective of this intention because their findings can contribute to an effective capacity-building at all levels of governance. The conference focused on the polycrisis and its impacts at various levels from the perspective of governments as well as other stakeholders.

Conference papers included various research papers relevant for the Main Conference Theme, 10 NISPAcee Working Groups, 7 Panel Sessions, an Open Session and pre-conference PhD seminar. More than 190 papers were presented. The Conference provided a forum for an open exchange of theoretical ideas, food for thought for the future and existing best practices. Special attention was given to the NISPAcee region but the conference aimed at the same time to make linkages with experiences globally with a special emphasis on perspectives, lessons learned and opportunities for an improvement of the quality of public services.

The Conference was attended by more than 220 participants from 31 countries. Participants evaluated highly the scientific as well as social programme of the conference.

NISPAcee expresses its deep gratitude to the host of the conference, the Faculty of Economics and Finance, University of Economics in Bratislava, for providing the conference facilities which created an exceptional, friendly and pleasant atmosphere for the participants and to the members of the Local Organizing Committee and conference assistants for the excellent organization. ### **Closing Roundtable: Public Administration and Democratic Governance in CEE, Europe and beyond**

### Brazil's Bahia State's mission to Estonia accelerates digital government agenda

Bahia State, Brazil expanded its expertise by visiting Estonia, a country that is a world leader in new technologies to leverage its digital government strategy. From March 16 to 22, managers from the Bahia State government (Brazil) took part in a mission to Estonia to exchange experiences and learn about initiatives with the potential to accelerate the development of the digital transformation agenda in Bahia State, Brazil.

The trip was a development of the technical cooperation agreement between the Bahia State Administration Secretariat (Saeb) and Estonia Hub, a company that promotes technological and commercial relations between Brazil and the European nation, for a diagnosis of the state's digital maturity.

During the mission, the group led by Edelvino Góes, Secretary of State Administration, learned about best practices in areas such as digital governance, education, innovation, and the modernization of public services. Among the members of the mission were managers from the secretariats of Administration, Public Security, Science, Technology and Innovation, Health, Communication, Education and the Civil House, as well as the Bahia State Data Processing Company (Prodeb), the Bahia Superintendence of Economic and Social

Studies (SEI), the State Traffic Department (Detran-Ba) and the State Water and Sanitation Company (Embasa).

As a result of the activity, Bahia State, Brazil, is already studying the possibility of new technical cooperation agreements, partnerships, and projects inspired by the Estonian experience. Among the novelties are initiatives in the areas of service design, artificial intelligence, technological architecture and data governance.

Estonia has stood out in recent years as a model digital society. The country has an ecosystem geared towards innovation and entrepreneurship, and is home to successful startups, as well as offering 99% of its services to citizens entirely digitally.
