Learning Conference on “Holistic Approaches for Implementing the 2030 Agenda for Sustainable Development in the Caribbean Region” (15-16 May 2019, Port of Spain, Trinidad and Tobago)



The Learning Conference on “Holistic Approaches for Implementing the 2030 Agenda for Sustainable Development in the Caribbean Region” was held from 15 to 16 May 2019 in Port of Spain, Trinidad and Tobago. Co-organized by UNDESA, UNITAR and ECLAC, the Conference provided a platform for practical learning and knowledge sharing among government representatives involved in the process of integrating the SDGs into their countries’ national development plans and budgets. 60 participants from 21 SIDS were present at the Learning Conference which highlighted issues related to the status of the implementation of the 2030 Agenda in the Caribbean, national experiences in localizing the SDGs, institutional arrangements as well as policy coherence, stakeholder engagement and partnerships for sustainable development.

Several UN regional and local agencies, as well as Resident Coordinators, attended the meeting, which concluded with a number of commitments and follow-up activities. The meeting provided an opportunity to raise awareness among Caribbean

countries of the importance of conducting VNRs. After two days of intense peer to peer learning, the

event was closed by Ms. Maria Francesca Spatolisano, Assistant Secretary-General for Policy Coordination and Inter-Agency Affairs of UN DESA, together with Mr. Nikhil Seth, Assistant Secretary-General, Executive Director of UNITAR, and Mr. Raúl García-Buchaca, Deputy Executive Secretary for Management and Programme Analysis of ECLAC.

Seminar on Smart Regional Governance & UN World Public Sector Report (13 May 2019, Shanghai, China)



The Seminar on “Smart Regional Governance & UN World Public Sector Report” was organized by the Institute of Information Sciences of Shanghai Academy of Social Sciences (SASS) and held at the Innovation Center of the Academy on 13 May 2019. Mr. Yu Xinhui, Secretary of the Party Committee of SASS, delivered the welcome speech. Mr. Zhu Juwang, Director of the Division for Public Institutions and Digital Government (DPIDG) of the United Nations Department of Economic and Social Affairs (UNDESA), delivered the keynote speech. Many experts and scholars from home and abroad, delivered thematic

presentations on the practice of regional intelligence governance, SDGs and other fields.

Director Zhu pointed out in his keynote speech entitled "Technology, Public Institutions and Regional Integration: Multilateral Perspectives" that breakthrough technologies such as life science technology, information technology and renewable energy have deepened regional integration. At the same time, different countries and different regions have different degrees of regional integration. The development gaps between various countries and groups are more notable. Countries should shift from a single-win perspective to a win-win one to enhance mutual cooperation, promote scientific and technological progress through more efficient use of public resources and promote national and global sustainable development.

Mr. Wai Min Kwok, Senior Governance and Public Administration Officer from UNDESA/DPIDG, introduced three dimensions of policy integration for sustainable development, global progress in sustainable development such as international migration and health around "Global Progress and Perspectives: Integration, Institutions and the Sustainable Development Goals (SDGS)".

The 27th NISPAce Annual Conference (24-26 May 2019, Prague, Czech Republic)



Organized in co-operation with Charles University, Prague and Masaryk University, Brno, the Main Conference Theme was: "From Policy Design to Policy Practice". Societal problems, as well as policy trials to solve them, are proving to be of an increasingly complex nature. This has brought about an even higher demand for evidence in the wider environment in which those problems arise and the right answers on how to solve them must be found. 275 participants - students, scholars and practitioners from the field of public policy and public administration from 43 countries met in Prague on May 24-26, 2019 to share theoretical perspectives, empirical findings and practical experiences in order to enhance the common competence of how to think and what to do in such a demanding context.

The IIAS-Lien 2019 Conference will take place at the Arc Learning Hub (Arc@NTU), in the Nanyang Technological University, Singapore from 18 to 21 June 2019. The World Public Sector Report 2019 now available




The World Public Sector Report 2019 is now available online. The report, entitled “Sustainable Development Goal 16: Focus on Public Institutions”, looks at national-level developments in relation to several concepts highlighted in the targets of Goal 16, which are viewed as institutional principles: access to information, transparency, accountability, anti-corruption, inclusiveness of decision-making processes, and non-discrimination.

The report surveys global trends in these areas, documenting both the availability of information on those trends and the status of knowledge about the effectiveness of related policies and institutional arrangements in different national contexts. It also demonstrates how the institutional principles of SDG 16 have been informing the development of institutions in various areas, including gender equality and women’s empowerment (SDG 5). The report examines two critical instruments that can support effective public institutions and public administration for the SDGs, namely national budget processes and risk management.

The World Public Sector Report 2019 aims to inform the first review of SDG 16 at the United Nations high-level political forum on sustainable development in July 2019, and to contribute to future efforts to monitor progress on SDG 16. By reviewing key challenges and opportunities for public institutions in

the context of the implementation of the 2030 Agenda at the national level, the report also aims to inform efforts by all countries to create effective institutions to deliver the Sustainable Development Goals.
